As such I have experienced the catalytic effect that well targeted State funds has made for this remarkable organization, which ran purely on dedicated volunteer energy for several years prior. fffff

Provision of a relatively modest infusion of state funds has had just the kind of amplifier effect one would hope. Maintaining its committed volunteer base and now provided with staffing assistance for some core functions, the Center has become a durable and effective civic organization for New Mainers, and for the Bangor community into which they must integrate.

I can attest that MMCC excels on a brass tacks level in helping immigrant individuals and families acclimate to the area, whether they be foreign professionals or refugees who are re-settling.
