




# CHILD ABUSE AND NEGLECT PREVENTION





# Testimony in Support of LD 1061, An Act to Increase Community Support for Families in Maine Provided by: Rileigh Blanchet April 4, 2025

# **Only allotted 3 Minutes**

Senator Ingwersen, Representative Meyer and members of the Joint Committee on Health and Human Services, my name is Rileigh Blanchet and I am the Social Services Director at Franklin County Children's Task Force as well as the Director for the Franklin County Prevention Council. I am also a life-long resident of Franklin County. Thank you for the opportunity to provide testimony in support of LD 1061.

The Maine Prevention Councils provide coordinated community efforts in each county to prevent child abuse and neglect through the provision of family-strengthening programs.

Our Prevention Council is embedded and led by Franklin County Children's Task Force. Our Prevention Council was selected as one of the first demonstration sites in the state and I have been fortunate to have been involved since the beginning.

What is clear to me is that community members and families need a go-to resource for support.

Families need people and places they can go to when they need help (without judgement). If I were to have any parent with me today, they would say that the Prevention Council has been that place, and those people, for them.

We support mandated reporters with training for OCFS. These in person trainings are highly sought after in our communities.

Upstream, community-based efforts to support families are a critical (and less costly) way to strengthen families and prevent the need for downstream (child protective agency) involvement

Every community benefits from having an entity that is focused on creating community events – these are opportunities for connection that build relationships and knowledge about resources that are available. At our annual Children's Festival this year, we had a new dental agency attend and every parent and child that requested an appointment with them was able to get a scheduled. At our Father Daughter Dances, we saw Dads building connections with other Dads, shaking hands, and shaking it off on the dance floor. There is one group of three Dads who comes to the dance every year and they have an annual tradition of meeting up before the dance to have dinner together with their daughters.

Through our Community Based Spaces work, Prevention Councils have convened community members, parents and providers alike to discuss specific community and family needs to identify opportunities in these communities. One story that always comes to mind when I mention the Community Based Spaces work happened at our Community Dinner this fall. We had over 40 parents, providers, and children in attendance at a local restaurant and one child looked at his mother and said, "Mom, I'm having dinner with my principal!" It gives me goosebumps every time I remember that sweet moment.

Parents deserve places they can go to enrich their parenting free of judgement. We know parenting is hard. Our parenting education programs, support groups, and play groups are a safe space for parents to make new connections, learn something they may not have considered, and provide an opportunity for their children to play.

## Testimony of Joe Whitmore Penquis Prevention Council In support, LD 1061, An Act to Increase Community Support for Families in Maine April 4, 2025

Senator Ingwersen, Representative Meyer, and members of the Health and Human Services Committee. My name is Joe Whitmore. I am testifying today in support of LD 1061.

The Maine Prevention Councils are the primary community entity that coordinates and provides support and services to strengthen families and keep children safe. This legislation would bolster their critical role and capacity to provide universal community support for families to promote child safety and family well-being.

As a parent, I have benefited from The Penquis Prevention Council in numerous ways. They were the only ones willing to help me find and take a parenting education class. We, as a family, didn't even know we were struggling. Although I recognized that my parents' parenting skills were not healthy, choosing to do the opposite was not enough. I was always there physically for my children, however, I struggled to be there emotionally. Penquis Prevention Council gave me resources, taught me healthy skills, and helped me understand how to be a responsible and Nurturing Father to my children. Without the support and help I received, I would not be the kind of Father I am today. I would not have the healthy connections, resources, or positive support system. I now belong to many local, State, and National organizations to lend my voice as a Parent with lived experiences to support and strengthen families. I have also maintained relationships with the Penquis Prevention Council. I continue to take parenting classes as my child grows, and I am the Parent Leadership team lead and help to co-facilitate the Nurturing Fathers Program, which allows me to give back to my community and state by supporting and promoting father involvement

Being a parent is hard, and families often feel alone. They need people and places they can go to when they need help (without judgment). When communities have resources, people, and places families can turn to, parents have opportunities to make healthy, strong connections and relationships that strengthen them and their families. Without the support and resources offered by the Prevention Councils, I would never have had the healthy, strong, and unbreakable bond that I have with my son or the bond I am working on with my daughter

Investing in the community's capacity to support families is so important to child safety and family well-being. An increased investment in the Prevention Councils represents an important opportunity to strengthen communities' ability to support families, to make sure they can get the help they need, when they need it – for parents and for their children. ### Testimony of Erin Whitham

Regarding LD 1061: An Act to Increase Community Support for Families in Maine

## Date: April 4, 2025

Senator Ingwersen, Representative Meyer, and members of the Health and Human Services Committee. My name is Erin Whitham. I am the Director of Social Services at Kennebec Valley Community Action Program in Waterville, Maine and serving all of Kennebec and Somerset Counties. The KVCAP Family Enrichment Councils in Kennebec and Somerset are part of Maine's statewide network of Child Abuse Prevention Councils, which coordinate county-level child abuse and neglect prevention efforts. The purpose of my testimony is to offer information about the important role Prevention Councils play coordinating support and prevention services to families in Maine.

Annually our Council leads a needs assessment process and develops a Prevention Plan that lays out our work for the next year with programming and supports that are responsive to our local communities' needs. In our area, that includes facilitating and leading parenting education, caregiver support groups, playgroups, family-friendly community events, distribution of concrete supports, and collaboration with a wide variety of community partners. The activities we carry out aim to strengthen protective factors among families and the community, the building blocks that help families thrive and prevent child abuse and neglect.

Prevention Councils are small—in Kennebec and Somerset, we are fortunate to have two Community Coordinators and two Community Educators, as well as a portion of my time as Director—and yet we have a unique and important role to play in strengthening systems of support for families. Through our broad network of partners we help connect families and providers to resources on a regular basis. Our team is knowledgeable about child development and parenting practices, and can help families troubleshoot parenting challenges or access more in depth information in the classes and workshops we facilitate on an ongoing basis. We are also committed to helping families meet their basic needs. A growing body of research shows that economic and concrete supports for families prevents child abuse and strengthens families, which is why we work with our network to distribute free diapers and wipes throughout both counties and connect families with other items, like cleaning supplies, clothing, strollers and car seats through free events like Community Baby Showers.

If you bring three people together in Kennebec and Somerset and ask them how the community can better support families, you will have five great ideas in about five minutes. Right now, the limiting factors for our Councils are staffing and funding. State funds make up the backbone of our program budgets, covering 90% of our personnel costs. Both counties have been flat funded since 2018 when funds were reduced from the previous year, while health insurance and salary expenses increase every year. While we have been successful in expanding our work through small grants, particularly

for concrete supports, which cannot be purchased with our state funds, it is rare to find a grant opportunity that will cover staff and operating expenses. In Somerset, we have one full time equivalent (FTE) for direct services for every 5,790 children in the county, and in Kennebec, it is one FTE per 15,347. Meanwhile, in 2023 Somerset had the highest rate of child maltreatment in the state, and Kennebec the third.

Here is a simple example of the network of community support we are trying to develop and strengthen. Last week, I took a call from a parent with a toddler referred to us by our local WIC office. The parent had reached out for food assistance, but her family was not eligible because they were over income. Still, between childcare, housing and utility costs the family was struggling to make ends meet after one parent had spent a few weeks out of work recovering from an injury. Each month they were trying to make \$200 stretch to cover food for a family of three, including a child on an expensive formula and transitioning to solid foods. Not only did they not have food for the weekend, they could not access food from their local foodbank because it is only open during both parents' working hours.

Fortunately, that local WIC staff person knew to connect the parent to us. We train WIC in Mandated Reporting, and collaborate throughout the year planning community events and referring families to one another's programs. WIC knows that right now we have a grant that allowed me to arrange a grocery store gift card for that parent, so that she would have food for the weekend. We also arranged a time when the parent could pick up diapers for her child and food that had been donated to us earlier in the week. After researching food resources with weekend and evening hours, I also connected the parent with Winslow Food Cupboard, a community rock star in our area, which distributes food at numerous locations at different times and days of the week.

This is child abuse prevention in action. It is parents reaching out for help, and providers partnering with them to knit supports together. Whether the ask is food or teething or isolation, Councils provide connective tissue to strengthen communities and families.

Thank you for this opportunity to share our work and the experiences of families in Kennebec and Somerset Counties.



#### Testimony of Charlene C. Corbett, MDiv. Healthy Kids! A Family Resource Network Designated Member of Maine's Prevention Council Network, Lincoln and Knox Counties In support, LD 1061, An Act to Increase Community Support for Families in Maine April 4, 2025

Senator Ingwersen, Representative Meyer, and members of the Health and Human Services Committee. My name is Charlene Corbett. I am the Executive Director of Healthy Kids! A Family Resource Network. Healthy Kids is the Designated Member of Maine's Prevention Council Network for Lincoln and Knox Counties. I am offering testimony today in support of LD 1061.

From our beginning in 1985, when the State designated the local network of parents and agency workers addressing child maltreatment issues in Lincoln County as one of Maine's child abuse and neglect councils, Healthy Kids has grown. Since 2023 we now serve both Lincoln and Knox Counties, providing families with concrete supports, parenting education classes, play groups, support groups, parent coaching, as well as offering professional training and a variety of community events, programs, resources and community referrals within our communities. We engage with all 37 towns in Lincoln and Knox counties, including 11 police departments, 8 school districts, 3 hospitals, 2 jails, the regional prison and multiple libraries, community centers and other area partners to support nearly 1,650 parents, children and professionals per month. We do all this with an active Board of nine members, 4.5 FTE staff, a legion of volunteers and ambassadors who are committed to the wellbeing of our communities, and strong, resilient parents who advocate for their families through our Parent Advisory Committee. We are collaborating with more community partners than ever before to address the multiple risk factors of child abuse and neglect in our area. We have also started an anti-stigma campaign through social media and local news outlets, encouraging parents to ask for help when it is needed, no matter the reason or barriers. All these efforts require community support and state investment in the safety of our children and wellbeing of families. We cannot do it alone.

Per Maine Department of Health and Human Services (DHHS) 2023 report, 3,633 Maine children between the ages of 0-17 were substantiated victims of maltreatment, 82 of which were children from Lincoln County and 84 of which were children from Knox County. Respectively, 34 of these children (41%) had a prior indicated/substantiated investigation in Lincoln County, while 47 children (56%) had a prior indicated/substantiated investigation in Knox County. Neglect and emotional or psychological abuse were the primary risk factors

found in Lincoln County, with 13 additional substantiated/indicated assessments of caretaker drug use. Additionally, 20 substance exposed Infant (SEI) notifications were submitted by medical personnel in Lincoln County in 2023. In Knox County, neglect, drug use and emotional/ psychological abuse are the three primary risk factors, closely followed by physical abuse, alcohol use and domestic violence. Additionally, 18 substance exposed infant (SEI) notifications were submitted by medical personnel in Knox County in 2023. Again, all these statistics only account for substantiated victims of maltreatment. These numbers are discouraging and hard to hear. Yet, from monitoring previous years reports, we are seeing a slight downward trend in our region. This calls for us to work harder, to commit even more resources and invest more in our communities, to keep this positive trend going! Prevention WORKS!

2025 marks the 40<sup>th</sup> year that Healthy Kids has been supporting families, protecting children and serving our local communities. Our anniversary theme, *Healthy Kids! Healthy Future!* reflects the positive impact we have achieved over four decades while also assuring the community that we are here to stay as a parenting and community resource for *all* families and those who work with children in Lincoln and Knox counties.

<u>Here's what one parent has said about our prevention council:</u> "I discovered Healthy Kids when I wanted to get my two-year-old some socialization. I was a stay-at-home mom and he mostly had adults for company. We began attending weekly playgroups and I immediately noticed positive changes in him. It was a good introduction and I decided to attend parenting classes. They've helped me gain knowledge and confidence as a parent. Healthy Kids! helps us to feel more connected to the community, which isn't always easy as a single parent of two toddlers." Shannon, St. George

I am also a long-time resident of Washington County and the mother of two boys, 10 and 6. Thank you for the opportunity to provide written testimony in support of LD 1061.

Known formally and in statute as the Maine Child Abuse and Neglect Prevention Councils, the purpose of the Maine Prevention Councils is to encourage and maintain coordinated community efforts in each county to prevent child abuse and neglect through the provision of family-strengthening programs.

Two of Maine's Prevention Councils are embedded and led by Sunrise Opportunities and each provides continuous year-round service as the counties primary agency that serves to encourage and coordinate community efforts to prevent child abuse from occurring. Sunrise Opportunities Prevention Councils provides a trusted, non-stigmatizing place for all parents and caregivers to receive the support all parents need from time to time.

Our Prevention Councils in Hancock and Washington counties offer a wide range of free services and parenting education to parents to include:

- concrete supports Heating assistance, diapers, formula, winter clothing, boots, blankets, etc
- public awareness activities and community events [GIVE EXAMPLES]

We also offer professional trainings to family-serving providers in:

- Mandated Reporting Prevention Councils deliver this OCFS-approved training and we would support
  updating to training to help participants understand the difference between a family who just needs
  support and child safety issues that should be reported to the child welfare. There is also a difference

Known formally as the Maine Child Abuse & Neglect Prevention Councils, the purpose of the Maine Prevention Councils is to encourage and maintain coordinated community efforts in each county to prevent child abuse and neglect through the provision of family-strengthening programs.

Two of Maine's Prevention Councils are embedded and lead by Penquis and each provides continuous year-round service as the counties primary agency that serves to encourage and coordinate community efforts to prevent child abuse from occurring. Penquis has supported two of the state's Prevention Councils for over 20 years and provides a trusted, non-stigmatizing place for all parents and caregivers to receive the support all parents need from time to time.

Our services include public awareness activities, child safety education, parent education, support and information for parents, referral to services and training for professionals.

In the last fiscal year in rural Piscataquis County served the following with .64 total staff covering 3,961 miles. In 2022, the number of children living in Piscataquis County was 3,017 children.

- **116** professionals were trained in Protective Factors, Infant Safe Sleep, Period of PURPLE Crying, and Mandated Reporting
- **116** parents/caregivers were reached through Parenting Education classes including Nurturing Parenting and Active Parenting
- 576 parents/caregivers and children built social connections through local playgroups and story times
- 1,623 individuals were reached through community events and activities

In this current program year in rural Piscataquis County with .64 total staff and in Penobscot County with 1.8 total staff the following was served

#### Testimony in Support of LD 1061: An Act to Increase Community Support for Families in Maine

#### Heidi Aakjer, Executive Director, Maine Children's Trust April 4, 2025

Good afternoon, Sen. Ingwerson, Rep. Meyer, and Distinguished Committee Members, my name is Heidi Aakjer and I'm the Executive Director of Maine Children's Trust. I am also a proud mother of two children under the age of 10 and have worked in child abuse prevention and child well-being efforts for over 20 years to include 9 of those years here in Maine working directly with the Maine Prevention Councils.

**Maine Children's Trust** was originally created by Statute in 1985 as a part of State Government. In 1994, legislation was enacted that transformed the Trust into a 501(c)3 non-profit governed by a Board of Directors. The Trust provides leadership and coordination of efforts throughout Maine to prevent child abuse and neglect. We provide funding and supports for prevention programming and awareness, as well as coordinates statewide collaborative initiatives to strengthen families. We are the only statewide organization solely focused on preventing child abuse and neglect before it occurs. Our mission is to strengthen families, promote healthy relationships, and support communities to prevent child abuse and neglect. Simply put - child abuse prevention means strengthening child and family well-being, which keeps children safe.

While the Trust does not provide direct service to families, these designations and our statute position us to expertly support direct service providers in national trends, innovations, best practices, education, public awareness, and professional development to meet families where they are and build upon their strengths.

Through contracts with the Maine Department of Health and Human Services (DHHS), we are responsible for providing the oversight and the system supports for the **Maine Child Abuse and Neglect Prevention Councils** (informally known as the Maine Prevention Councils). This includes management, technical assistance, training, quality assurance and improvement, data collection, and reporting. Maine Children's Trust has supported the Maine Prevention Councils since the 1990s through grants, awareness, and technical assistance. Since 2008, DHHS has partnered with the Trust to lead and coordinate statewide child abuse prevention efforts. In 2015, DHHS provided funding to establish a formal statewide infrastructure for the Maine Prevention Councils, which statutorily serve as county-level coordinators for prevention programs and supports. Unfortunately, since that time funding has never increased and funding for counties has and is not equally distributed among counties.

The Maine Prevention Councils provide many support services to local families and communities and are in statute to provide these services countywide. They provide parenting education, which are evidence-based, multi-week classes, as well as peer support groups, and playgroups for parents to be with their children in a supportive and peer environment. They also provide concrete supports – things like diapers, wipes, formula, clothes for the winter, and they also hold community events such as community baby showers and other family gathering efforts. Additionally, they offer professional trainings such as Mandated Reporting along with Infant Safe Aleep, Abusive Head Trauma Prevention, and Protective Factor training.



Most recently, the Prevention Councils were selected to support a one-time budget initiative, as a part of the **Maine Child Safety and Family Well-Being Plan**. This effort was to partner with the community, parents, caregivers, and youth to locate Community Based-Spaces for families in every county and assess opportunities to enhance or expand these spaces locally. To maximize the efforts in support of child and family well-being, the development of a Maine-specific framework for community-based spaces for families informed by the National Family Support Network (NFSN), a national organization that supports family resource and success centers model nationally. (Maine Children's Trust is the state lead for NFSN.) The Maine Prevention Councils convened nearly 23,335 community partners, parents, caregivers, and youth. They also identified 698 community-based spaces for families that met the identified criteria, and an additional 399 that met some, but not all, criteria. During this process, the Maine Prevention Councils also identified unique opportunities in every county to enhance or expand these spaces and spark ongoing community collaboration.

It is important to note, that they conduct this county-wide work in partnership with families with a total staff of 17.61 FTEs who are direct service staff that cover the state of Maine. That is only .64FTE per county for a Community Educator who provides the parenting education and support directly to families and with .45FTE per county for a Community Coordinator who supports building partnership with their communities, professional trainings, and efforts like the community-based spaces. In FY24, half of Maine counties received less than \$55,000 in total program support and staffing to prevent child abuse and neglect.

LD 1061 would provide cost effective and equitable staffing support for every county in Maine. It would support and bolster alignment with the Child Safety and Family Well-Being Plan to meet the needs of families, support primary prevention, strengthening communities, and partner with parents and community members to join together to increase child and family well-being. With support from LD 1061, we can ensure that all children and families in Maine have a trusted local resource and staff for support and prevent costly interventions for child abuse in the future. I strongly urge you to support LD 1061 on behalf of children and families across Maine.
