My name is Jeff Strout. I am here today to support LD 1243, HP0818. An Act Regarding the Licensing of Assisted Living Facilities. I am the owner of Atlantic Shores, a Level III Adult Family Care Home (AFCH) in Harrington, Maine, Washington County. In addition to being the owner, I am also a PSS (Personal Support Specialist) and a CRMA (Certified Residential Medication Aide) and work along with my staff caring for our residents. Seasonally I am a lobster fisherman with my season being May through December.

I am testifying regarding a change in the law which now prohibits me from opening a second, even though connected by a wall, a physically separate, Level III Adult Family Care Home at the same location as Atlantic Shores.

In 2018, I seriously started thinking about starting an AFCH. The need was in high demand, especially in our small coastal town in Downeast Maine. With building permits and blueprints approved, construction was started. The project was completed in May of 2019 and our home, Atlantic Shores, was licensed as a Level III AFCH.

By 2020, the demand for homes that provided quality care was increasing. In our community, nursing homes were closing. As my waiting list for long term care placement grew, I began to consider opening a second home. I made the decision to renovate and build another Level III AFCH.

During this time, I had conversations with the Fire Marshals Office and Licensing. Still unaware of the law change that would be effective October 2023, I did not rush to license the new facility. (Again, please keep in mind, my busy time for lobstering is May through December.) I had taken my time. I wanted everything perfect! I looked back at Atlantic Shores and asked myself, If I had to do it all over again, what would I change? What would I improve? I designed and built six **larger** bedrooms, all with heat pumps as well as radiant in-floor heat, an ADA bathroom with a huge walk-in shower, an organized laundry room, a hallway that an ambulance stretcher can easily maneuver through, two spacious living rooms and a dining room that has ample seating. I completed and mailed the Bold Coast application with all required documentation to the Department for licensing. Much to my surprise, I was notified in April 2024 of a denial for licensure as an AFCH Level III due to changes in the law that had gone into effect October 2023 It was suggested my options were to reapply for a license as a Level IV PNMI or Level IV Residential Care. **Neither** 

**option is reimbursable by MaineCare**. Fact: 83.4% of the residents at Atlantic Shores have MaineCare as the primary payer source. That's 5 out of 6 residents that has MaineCare and the 1 resident who is private pay...applied for MaineCare last month.

As for my family, they enjoy sharing our home with the residents. My kids look forward to spending time with each one of them as much as the residents look forward to interacting with the kids. This interaction prompted my youngest daughter to get her CNA and go to Washington County Community College to get her business degree with plans of someday owning and operating Atlantic Shores and Bold Coast Adult Family Care Homes.

I feel the need to testify to hopefully help you understand that there are GOOD homes that should be licensed. GOOD homes that do follow the rules. GOOD homes that provide quality care. The location shouldn't matter. I may also add, Atlantic Shores has had excellent Case Mix reviews! Excellent DHHS surveys! Excellent Long Term Payment Reviews! Zero complaint investigations!

My solution...I hope you will accept the presented revision of the newly enacted law and allow Bold Coast to be licensed as a Level III AFCH.

And again, thank you for your time and consideration on this matter. It is greatly appreciated. I would be happy to answer any questions you may have.

My name is Cindy Strout and I am from Harrington, Maine within the great Washington County. I am a nurse and had the pleasure of being a former owner of two AFCHs. I currently oversee paperwork for my families' AFCHs as well as continue to work part time at Harrington Family Health Center. And.....Jeff is my oldest son.

My letter is regarding the change in the law beginning October 1, 2023, that the department may not issue more than one license at the same level to an applicant for an assisted living facility or a residential care facility for services offered in the same location.

In 1993 lawmakers and health officials initiated a policy change and introduced the Adult Family Care Home models for our aging population. They were aimed to shift the focus from nursing homes to "more home-like, less institutional" alternative homes and were a pivotal move, driven by a severe budget crunch. I have been involved with Adult Family Care Homes since 1998, owning two licensed homes. I had the honor of taking care of my mother at home until she passed away in 1997. It was that heart touching experience that led me to decide to explore, then open an Adult Family Care Home. My first home was in Harrington. The Grace Home was licensed a Level III AFCH in 1998 and then a Level IV in 2000. In 2004, I renovated my old family home in Franklin and licensed it as my second Level IV AFCH. The homes were 20 miles apart. There were challenges running/operating the home from a distance. I lived at The Grace Home and drove to Mountain Vista 3 or 4 days a week. I have always said it would have been better to have both homes under one roof. I would have been able to have more "eyes on/hands on" instead of the way I did it. Unfortunately, I experienced a family tragedy and sold both homes in 2012.

My solution...allow for the revision of the law and instead of penalizing facilities that operate within the rules and regulations, monitor and sanction the facilities that do not.

Again, thank you for your time and consideration for letting me briefly touch on a subject that is near and dear to my heart. It is greatly appreciated!
