During the 131st Legislature brought before this committee and act to align title requirements with the same timeline used for Antique Auto's, (25 years) with a rolling number instead of a specific model years as previously set in Statue.

That bill was came out of this committee with some minor language changes suggested by the Secretary of State and this Committee passed that bill and that is now chaptered law. I want to thank this committee for that.

During the second regular session, this committee also changed the antique auto requirements from 25 years to 35 years in a department clean up bill, and that is why I am here today.

I have had several constituents reach out to me who are now unable to register their 25 year old vehicle as an antique.

I reached out to Secretary Bellows directly and was trying to get some rationale for the change last year in the department bill. We discussed an example of someone registering a 25 year old Honda Civic and skirting the inspection requirements to operate that vehicle as their daily driver.

vehicle used as that person's primary mode of transportation of passengers or goods is not registered and insured. A person who violates this subsection commits a civil violation for which a fine of not more than \$2,500 may be adjudged and for which the Secretary of State may immediately revoke the registration for the antique auto.
