LD, 1788 An Act to Strengthen the Freedom of Access Act by Categorizing Commercial Requesters

May 2, 2025

Good afternoon, Chair Carney, Chair Kuhn, and honorable Members of the Joint Standing Committee on Judiciary. My name is Abby and I live in Norway. I am here representing the Oxford County Administration Office as the main point of contact for FOAA requests in our agency. I work with our legal team and department heads to acknowledge and fulfill these requests.

I have worked in the Oxford County Administration Office since 2015 and have experienced firsthand the progression of FOAA requests. Not only has the number of requests multiplied, but the nature of the requests themselves has also shifted.

Oxford County is determined to be as transparent as possible to our constituents and the general public; however, most of the requests we receive are deviating from that notion. When I first started at Oxford County, FOAA requests were fairly rare and typically from journalists, reporters, or members of the public regarding budgeting matters, personnel practices, or anything that would relate to the management and oversight of county operations. The majority of requests we receive today seem to be related to more specific matters, such as data compilation and individual disputes/legal matters.

We are not sure what is causing it, but there has been a clear increase of attorneys and prose defendants utilizing the FOAA system to expedite or circumvent the discovery process. These requests entail police reports, bodycam footage, 911 call information, etc. which will be provided to them twice now.

Responding to these requests are costly in time, money, and resources. The number of requests and how frequently they are received has resulted in a backlog of requests which makes managing the requests even more difficult and distracts essential personnel from other business matters.

Oxford County has incurred over \$63,000 in legal fees associated with responding to the influx of FOAA requests in the past two years alone, and over \$13,000 the first quarter of 2025. Although current FOAA rules allow for recovering a portion of the fees associated with responding to requests, the billing and oversight process of managing that system in itself would incur more time and resources than we would be able to recoup.

Oxford is not the only county in Maine being impacted by the increase in FOAA requests. It is the topic at many events where County Officials come together to discuss general business. Attached to my testimony is a sample log of recent requests of which 30% are from attorneys who will otherwise receive these documents in discovery,12.5% from private companies compiling data for sale online, and 57% are regarding individual legal matters or disputes such as a car accident or argument with a neighbor – essentially topics that the general public wouldn't care or know about unless directly involved.

Oxford County is proud of our mission and our employees' dedication to serving the public. We want to do everything we can to be open and engage the public with county governmental matters which is why we are seeking a change to the FOAA system guidelines to ensure we are prioritizing our duties appropriately.
