Senator Hickman, Representative Supica and distinguished members of the Joint Standing Committee on Veterans and Legal Affairs, good morning. My name is Alicia Rea and I am a policy fellow at the American Civil Liberties Union of Maine, a statewide organization committed to advancing and preserving civil liberties guaranteed by the Maine and U.S. Constitutions. On behalf of our members, I urge you to reject LD 1437.

The ACLU of Maine has a deep commitment to protecting and expanding both voting rights and immigrants rights. We firmly believe that our democracy is stronger when as many people as possible have a voice. That is why we have already urged you this session to consider ways to expand and strengthen, rather than constrict and exclude, participation in our voting process.

Although voting in Maine has always been restricted to citizens, this has not always been true across the country. Between 1776 and 1926, 40 states and federal territories allowed non-citizens to vote in elections and hold public offices.¹ It was only when fear and xenophobia took hold, marked by even the Washington Post commenting on the marked and increasing deterioration in the quality of immigration, that states began to restrict voting to citizens only.²

Everyone who pays taxes, lives in community, and sends their children to local schools should have a voice in how their community is governed. Given that Maine schools are currently struggling to meet the needs of their students and communities, more community involvement in how schools are run is going to help make our schools more responsive and successful. Moreover, all taxpayers should help decide how tax dollars are spent. The principle that taxation should entail representation was a key reason the American colonies declared independence in 1776.

Finally, if towns and cities in Maine wish to amend their charters to give their residents a voice in municipal elections, the legislature should not create a Constitutional barrier. The committee should not give in to the urge to
