> Testimony of Lieutenant Jason Richards Maine State Police

In Support of LD 1944

LD1944 An Act to Protect Children and Adults from Technology-facilitated Summary Sponsored by Representative Kuhn Joint Standing Committee on Judiciary

Senator Carney, Representative Kuhn and other distinguished members of the joint standing committee on Judiciary. My name is Lieutenant Jason Richards. I oversee the Maine State Police Computer Crimes Unit, and I am the commander of the Northern New England Internet Crimes Against Children Task Force. I am here representing the Maine State Police and the Department of Public Safety and to testify in support of LD 1944 and the protection it would provide to exploited children and other victims of crime in Maine.

I have been directly involved in investigating physically and sexually abused children and sexually exploited children in Maine for the past 21 years. I have unfortunately seen all the ways in which children can be victimized increase exponentially during that time. The newest threat our communities and our children are faced with is artificially generated or enhanced images and videos used to extort and exploit them in ways never seen before. While Generative AI has many wonderful uses, with technology, comes people who will use the technology to victimize others.

It is important to understand how generative AI works. To steal from the all-knowing Google, Generative AI models use neural networks to learn patterns and structures within existing data, then create new, original content based on those learned patterns. The key phrase here to consider is "within existing data". AI Models can be trained on a variety of data, including text, images, and audio, and can generate new content in those same formats. In other words, many of the websites and platforms used to generate child sexual abuse material, at their basic level, are reliant upon images of known sexually abused children to re-violate them in creating new images and videos from that existing content. I am not allowed to show you this imagery and have to ask you to trust me when I tell you, there is no limit to graphic, obscene, sexual and abusive nature of this content.

I field calls regularly from concerned prosecutors, police officers and parents from around our state posing two scenarios ever present with this material. Either a person has altered an image of their child to create an obscene image or video that is now out in the world to be forever traded and sold or the created image is being used to extort the child in some manner. In either case, I have to tell them there is nothing we can do as these scenarios are not a violation of Maine law.


LD1944 provides a manner in which this conduct can be investigated and if appropriate, for people to be held accountable for using this technology to exploit children in new ways.


It is for these reasons that we support LD 1944.




