RE: Name signs for bridges

Dear Senator Jim Libby,

The Standish Town Council would like to request bridge name *signs* for two of our bridges. They are Canal Bridge (BR2123) located at Rt 35 in Standish and East Limington Bridge (BR2252) located at RT 25 Limington/Standish. We believe clear and informative signage would greatly benefit residents, visitors, and emergency services.

Currently, the signage for these bridges is either absent or insufficient to clearly identify it by its local name. This lack of clear identification can lead to confusion for individuals unfamiliar with the area, particularly in situations requiring navigation, directions, or emergency response.

We understand a legislative resolve is required before collaborating with Maine Department of Transportation for installation. We believe the signage for the mentioned bridges would be a valuable addition to our community and we would be grateful to receive a favorable response.
