TESTIMONY

In support of MDACF Bureau of Parks and Lands provisions within LD 2212, Governor's proposed FY 2026-2027 Supplemental Budget.

And urging that LD 2212 be amended to include funding for LD 761 State Historic Sites

Senators Rotundo and Talbot Ross, Representatives Gattine and Pluecker, and members of the Appropriations and Financial Affairs and the Agriculture, Conservation, and Forestry Committees:

My name is Alan Stearns. I am one of several people actively working to form the all-volunteer Friends of Parks & Lands, for the primary purpose of building legislative and congressional support for Maine State Parks and Maine Public Lands, all at the Bureau of Parks & Lands (BPL). We are a volunteer group in formation, with incorporation and other governance steps happening very soon.

As volunteers, we are stepping to the plate because of our recognition that the financial resources of BPL are stretched to a breaking point, with consequences. Record growth in the use of state parks requires resources. So too, new trails and treasured public lands require resources. We note many concerning trends affecting the Bureau regarding timber markets, inflation, work force, and climate change. We plan to work with the legislature over the long term to ensure the BPL remains a strong guardian of visitor experiences to Maine's most iconic mountains, lakes, beaches, trails, and forests.

The good news is that the Governor's proposed supplemental budget includes several provisions and appropriations which provide short-term fixes for some BPL issues. Our testimony today is in support of all of the provisions related to BPL.

We note especially the appropriation of \$2.25 million for Public Reserved Lands, responding to declining timber market values. Historically, BPL's timber revenues have largely funded all expenses that keep more than 600,000 acres of public reserved lands free, open, and cherished for hunters, hikers, anglers, campers, bikes, ATVs, and more. While we can hope that timber market forces reverse themselves, we know that this one-time \$2 million fix is merely a

short-term fix. We have offered to work with the Bureau to bring longer term analysis and longer term budget approaches to the next Governor and the next Legislature.

So, too, the next Governor and the next Legislature will need to address significant issues within the Parks personnel structure. Recruitment and retention of Parks employees continues to be a severe problem.

While we support the Governor's proposed budget, we note with concern the lack of funding for State Historic Sites or funding for LD 761. LD 761 is now on the Appropriations table, after unanimous votes in the ACF Committee and on the floor last year. Earlier this year, a bipartisan list of 26 legislators wrote to the Governor, urging funding. Those legislators are:

Today we ask that both Committee amendments and Executive change packages be used to provide much needed capital funds for BPL's State Historic Sites. **The Maine Legislature has**

the opportunity to use this year's one-time budget surplus for crucial long-term investments in State Historic Sites.

The Bureau last year gave you a list of more than \$30M in compelling needs at State Historic Sites and National Register sites within State Parks. LD 761 recommends \$18M in funding to start. Today, below, we highlight six State Historic Sites that illustrate priorities totalling just over \$16M. As noted below, **three of these State Historic Sites are closed due to lack of resources for capital investment, and also listed by Maine Preservation among Maine's Most Endangered Historic Places, including two sites that are important for this year's 250th anniversary of the American Revolution.** Finally, there is the risk that competitive federal funds will not be awarded if we can't find the required 50% match for those federal funds.
