The **SPEAKER**: The Chair recognizes the Representative from Lincoln, Representative Gifford.

Representative **GIFFORD**: Thank you, Mr. Speaker. I rise today to speak to my dear friend and colleague, Everett McLeod. My good friend and colleague, Representative McLeod, can't be with us today. Everett was known in the '60s for a Sunoco Station in Lincoln. He was also known for his Corvette. He owned and raced that Corvette and was very proud of that, and I can tell you that he and Archie McGinley were a pair that took a full house to beat in those days.

Everett and I kind of separated and raised families in the '60s, and I didn't get a chance to really meet Everett and associate with him until the '80s. When we became acquainted, Everett at that time was selling for Gilman Electric, I believe it was, and covered most of the state. I got involved in politics back in those days and was distributing a little paper for the Unorganized Territories United, and Everett used to take them from Lincoln and distribute them up into Madawaska for me. After that period of time, we discovered that our views are very much the same and when I decided to run for the Legislature, of course Everett had already been here one term, and so we kind of formed a bond that we had previously. And Everett, at that time, he still had the same Corvette, plus he had a few more antique cars that he had accumulated in that time. He also had a wife and fine family that I've become acquainted with, and we really became very close.

It is with the deepest respect that I stand before this body today to promote Everett, and he was a like a rock to me the first couple of years I was here, because you are looking for somebody that is solid and steadfast that you can look to. In his spending and his budget philosophies, he was like a rock. Between him and Henry Joy, I had a pretty good pair to compare notes with, so I really respect that. I can still call Henry today, but I have to pray for Everett. I ask that all of you keep Everett and his family in your prayers today. I wish his family the best. They are with us today up in the balcony. We have all lost a great friend and someone who was like a rock in his belief, in friendship and Christianity. Everett is the reason for the bibles on each of your desks. Most people didn't know that but Representative McLeod was instrumental in putting those bibles on your desks, it was that important to him, so take that with great honor. My wife and I became very close to Sarah and Everett the past four years and we all lost a good friend in December. So I hope you will join me today in wishing Everett, and his family up in the balcony, the best.

The **SPEAKER**: The Chair recognizes the Representative from Cumberland, Representative Strang Burgess.

Representative **STRANG BURGESS**: Thank you, Mr. Speaker. Mr. Speaker, fellow Members of the House. I rise today to add a little bit more perspective, perhaps, to Representative McLeod. Some of you folks didn't have the

pleasure and honor of knowing him. He was my seatmate for the last two sessions and also was a rock for me. It was just a pure pleasure to share that time. I think you'll all, those of you who have been here for a while, know the bond that does get formed. It's not political, it's just person to person. It's a special bond that we have, one that we honor today.

Everett worked me over pretty hard. As some of you know, I tend to kind of cruise through the middle of life, swerving along here, and Everett you could pretty much count on to be slightly righter than me. And as we would come up to these critical votes, he'd lean over to me and say "You know you can do it, you can vote red. You can do it, you can do it." You know, I think last session I voted red on more things that I had ever done, you know? And they would cheer when I would vote red on anything. It was like, yes, yes, she does know where the red button is.

Everett was just a solid, solid human being. I didn't have the pleasure of knowing Everett until 2006, is when I met Everett. He was always very supportive of my cancer issues. Some of you folks that are new haven't heard my speeches, but, unfortunately, they are coming. Look out. And Everett is yet one of those reasons that I continue to do what I do, which is that cancer is a despicable disease. I hate it and it needs to stop. It is the number one killer in Maine. As a cancer survivor myself, Everett and I then shared the special bond of being cancer survivors together. We talked about treatment, stuff that you know you can only sort of talk to with someone who has been there, done that. He was a great man of deep, deep faith. He approached everything in a very pragmatic, fair, deliberative process to everything, and he faced his cancer the same way. He was absolutely sure that everything was going to be A-OK, and he had me convinced it was going to be A-OK. Well, it didn't work out that way, and I hate that part. For this session when we started up, I requested to have Everett as my seatmate, and then he wasn't able to actually be here.

Some of you have seen on his desk here in the chamber a picture that was taken the last day of session, last April 12th, I think it was a Monday. You will learn that towards the end of session we all get a little punchy, and I have some rabbit ears, that when you see me wearing the rabbit ears you know that the session is coming to a close. And Everett liked all of the toys. We had Representative Jayne Giles as my other seatmate and something that happened in our early session that we got labeled into the "bunny rabbit club" somehow, and we had little bunnies and things, and Everett thought we were absolutely crazy. But he said, you guys make me laugh, you help me keep perspective, and he loved it when the bunny ears came out. And somebody was taking pictures in the chamber, probably Representative Prescott, and took that picture, and I love that picture. Not that I wish I wasn't in it, but I love that picture of Everett. His eyes are sparkling and he was full of life and full of fun. That's who he was, that's who he was, and he took his responsibilities here in Augusta so seriously, represented his home territories so well. I didn't make it up for the ceremony and I felt really bad about that. I had a chance to talk to the family this morning, I'm so glad they are here, and I want them to know that they are in my heart and prayers, and I'll miss Everett very much. Thank you.

The **SPEAKER**: The Chair recognizes the Representative from Millinocket, Representative Clark.

Representative **CLARK**: Thank you, Mr. Speaker. Mr. Speaker, Men and Women of the House. I really got to know Representative McLeod in the last couple of years, particularly chairing Inland, Fisheries and Wildlife, but I wanted to give you a little history before I get there.

I always used to see Everett come through the mill where I worked. He always had a smile on his face. He always took a

minute to talk to people, a very gentle, caring, kind individual. I had a great opportunity to work with his brother and I wanted to tell you a little story. Back many years ago, smelting was very big in the area, and Everett's brother and I and another gentleman used to like to go ice fishing. Well, it was a school vacation in April and I had a few extra dollars in my pocket that I could spend. My wife and I and my children, we went to Florida. Well in Florida I received a phone call from my father saying that Everett's brother had passed away. They went through the ice that night, him and the other individual. And if I was there, I would have been there too.

But I think it was a blessing knowing his brother Arthur and knowing Everett, because a lot of people didn't really understand Everett. Sometimes he could be a little rough and gruff, but deep down inside he was a really caring individual. He really represented his district extremely well. Sitting over here, and I would be sitting in 55, and the light would come on, he would turn over and give me that smile and thumbs up. It would be 145 yes and there would be Everett no. And he believed what he believed in. He did not come down here representing himself. He came down here representing the people who elected him to be here. And time and time again, a lot of us forget that.

I went through a little bout last year. As some of you know I served here last session. The first one to come to my side was Everett and he shared with me a letter that he had that was really meaningful and I made a copy of that and I still have that at home. My wife has a lot of family members in Lee and Everett knew my Aunt Helen. Anybody in Lee, who knows Aunt Helen, knows she likes to talk, likes to listen and likes to know what's going on. Everett used to communicate with her, time and time again, either through letters or him stopping in and seeing her.

In each and every one of your desks there should be something that Everett gave to each and every one of us. There is a bible. Take some time and look at that because it will bring back memories of Everett McLeod, because he was a caring, religious individual who put people first and him second. And Mr. Speaker, knowing that Everett always liked to push his light red, when we adjourn today, I'd like to have you open up the voting and each and every one of you vote red in his memory. Thank you very much, Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Whiting, Representative Burns.

Representative **BURNS**: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House, Sarah and family. It is a great honor for me to speak on behalf of Representative McLeod today. I came to know Everett in my first term here. I had an opportunity to serve with him on the Government Oversight Committee and my first indication that he was really a special person, as has been mentioned here today, was the first day that I arrived in this chamber there was the New Testament sitting on my desk as there was for everyone else. I soon found out who that came from and I soon came to realize exactly why he felt compelled to do that, and he did that again this term.

Very soon after I met him, I came to know him as a very strong willed, strong character individual, a man of incredible strong faith and relationship with his Lord and Savior, Jesus Christ, and his love for his family. That carried Everett a long ways and impacted a lot of people.

My very first perspective of Everett came to be true that he was a very no-nonsense guy, but he always seemed to have a positive way of delivering his opinions and his objectives to you, no matter how strongly he felt about it. Our common bond of faith and family first allowed us to become very good friends and allowed us to share some of the same goals in life. On a lighter note, we both shared the love and ownership of Corvettes and

Supersports. So I always could go to Everett to ask him where I could buy parts for my Supersport and about my Corvette. He was quite a guy, I really miss him. I really look forward to seeing him again. Thank you.

The SPEAKER: The Chair recognizes the Representative from Topsham, Representative Prescott.

Representative **PRESCOTT**: Thank you, Mr. Speaker. Everett McLeod will always hold a special place in my heart. He was the Representative who always smiled. He wore a black leather jacket and got away with it, and he always spoke his mind but with class and distinction. There was a day, I just want to share this one quick story with everybody here today, he held his hand out to me. I thought he was going to share some M&Ms to try to get me in trouble for having food in the chamber; however, instead he dropped a starfish pin into the palm of my hand. I looked at him and I said, "Why? This is really nice of you." He said, "Well, I know you like pins and I know you are a member of the Marine Resources Committee and I thought it would be a nice addition to your wardrobe." So I have always worn that pin with pride and I just want to know, Everett, that if you are listening today, you will always be the shining star.

The SPEAKER: The Chair recognizes the Representative from Windham, Representative Plummer.

Representative **PLUMMER**: Thank you, Mr. Speaker. Mr. Speaker, Men and Women of the House. I am very proud to say that I served in the 122nd, 123rd, 124th and, yes, the 125th session of the Maine Legislature with Everett McLeod. I am proud and honored to say that Everett was my friend. I will hold Everett and his family in my thoughts and prayers.

The SPEAKER: The Chair recognizes the Representative from Brewer, Representative Celli.

Representative **CELLI**: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. Everett was a special person who has touched many, many lives, not only his family but in this chamber. He was instrumental in helping me become a Representative, learning how to be a Representative. People have heard me say this before, but it really had meaning in this case. On your tombstone there are two dates. They are usually the most worthless dates of your life. You can't do anything, you're usually crying, eating, sleeping, and that's about it on those two dates. What's important is that dash in between your two dates and how much better the world is because you were in it. That's what that dash represents. There is not a tombstone in this state big enough for Everett's dash. Thank you, Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Orono, Representative Cain.

Representative **CAIN**: Thank you, Mr. Speaker. Mr. Speaker, Men and Women of the House. On behalf of my caucus, I rise to honor Representative McLeod and his service here in Augusta. Everett and I came in on the same day and we probably were about as opposite of people as you could ever get to come into the chamber on that same day in 2004. But from that very first day when we were sworn in to our first term, what I knew and recognized about Everett McLeod was his smile. Before I ever knew his name, I knew his smile. It was huge and, no matter what, when he smiled at you, you were compelled, almost forced to smile back. No matter how awful your day was, no matter what you had on your mind, you couldn't help but return the favor he extended to you. I could always count on that smile and his friendly hello, and I miss it here everyday. I have missed it since swearing-in day in December. And when I drove up for the memorial service, what I was struck by was in every single photo, every silly photo of Everett, was that smile. It's unwavering. And even if cancer had shrunk the size of his body,

it never shrunk the size of that smile, not even a little bit. That amazing, contagious and genuine smile only seemed to shine brighter. Our thoughts and prayers are with Everett's family, they will continue to be, and we are all thankful for the time that our friend and colleague, Everett McLeod, spent with us. And we will always remember him, and especially his smile. Thank you, Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Madison, Representative Curtis.

Representative **CURTIS**: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House and honored guests. I would like to take a few moments to share remembrances of my good friend, the Honorable Everett McLeod.

Everett always had the ability to quietly lead and persuade others to his point of view. I often thought it must have been because of his unique natural salesmanship, but when I reflect back on the many conversations and the observations, it was because Everett was genuine.

He never had to try to sell his stance or fabricate reasons for a vote. His beliefs, whether for or against any piece of legislation, and most of them were against, were simply stated and only given after much thought, much consideration, and guided by his faith in God.

Everett was also honored to represent the citizens of District 11. Any returning member that had the opportunity to hear Everett talk about his portion of our great state would hear him refer to it as the most beautiful portion and the most beautiful district in the State of Maine.

With every presentation of testimony Everett would not just refer to his legislative district by number but would call off every town, every plantation, and territory. I, Mr. Speaker, would be honored to do so for him now; District 11 comprised of the towns of Burlington, Chester, Danforth, Lakeville, Lee, Lowell, Mattawamkeag, Passadumkeag, Princeton, Springfield, Talmadge, Topsyfield, Vanceboro, Waite, Winn, Woodville; Plantations of Carroll, Codyville, Drew, Grand Lake Stream and Webster; the Unorganized Territories of part of East Hancock, part of North Washington, including Brookton, Forest City, Kossuth, Lambert Lake and No. 21 Townships, Grand Falls, Greenfield, Kingman, Prentiss, Summit, Twombly and Whitney Townships.

The residents of Everett's district lost an admirable man, we lost an honorable and valuable member of this body, but we all are better for having known Everett. On behalf of the 125th Legislature and the citizens of the State of Maine, we express our appreciation to Everett's wife, Sarah and their family for sharing Everett with us. We were and are truly blessed. God bless his soul and may he continue to watch over us.
