Bill "An Act To Extend Civil Rights Protections to All People Regardless of Sexual Orientation"

S.P. 413 L.D. 1196

In Senate, March 29, 2005, **PASSED TO BE ENGROSSED.**

Comes from the House, **PASSED TO BE ENGROSSED AS AMENDED BY HOUSE AMENDMENT "I" (H-92)**, in **NON-CONCURRENCE.**

Senator **HOBBS** of York moved the Senate **RECEDE** and **CONCUR.**

**THE PRESIDENT:** The Chair recognizes the Senator from York, Senator **Hobbs**.

Senator **HOBBS:** Thank you, Madame President and members of the Senate. I'll call your attention to House Amendment "I" (H-92) that has been attached to this bill. I just wanted to clarify what this particular amendment does. This amendment provides that the bill may not be construed to change any right to marry that exists under the United States Constitution, the Maine Constitution, or any law of the state. The original bill, which was voted on in this body, there was no nexus between what is known as the defense of marriage act, what is known as gay marriage, and the original bill. However, this amendment will make sure that everyone knows that there is no nexus and it was decided by both the opponents and the proponents that it would be better to, for clarification sake, even though it doesn't need to be clarified, have this amendment on the bill.

On further motion by Senator **HOBBS** of York, supported by a Division of one-fifth of the members present and voting, a Roll Call was ordered.

The Doorkeepers secured the Chamber.

The Secretary opened the vote.
