(Note: this transfer was implemented by Public Law 1999, chapter 401).

Committee Amendment "A" (S-714) proposed to replace the bill. It would change the title of the bill and clarify the manner in which the Maine Rainy Day Fund may receive surplus General Fund revenue at the end of a fiscal year. It also proposed to direct investment income that would otherwise accrue to the General Fund when the Maine Rainy Day Fund is at its 6% cap to be transferred to the Retirement Allowance Fund, effective in fiscal year 2002-03. This amendment also proposed to add a fiscal note to the bill.

Senate Amendment "A" to Committee Amendment "A" (S-738) proposed to require that the investment income from the Maine Rainy Day Fund that would otherwise be transferred to the General Fund be transferred instead, in equal amounts, to the Retirement Allowance Fund and a fund would be established by the Department of Education for improvement of school facilities. No transfer would be made until after July 1, 2003, pursuant to the effective date in Committee Amendment "A."

Enacted Law Summary:

Public Law 1999, chapter 749 clarifies the manner in which the Maine Rainy Day Fund receives surplus General Fund revenue at the end of each year, clarifying that the Maine Rainy Day Fund transfer is the first priority before any other transfer. Effective July 1, 2003, it also directs investment income that would otherwise accrue to the General Fund when the Maine Rainy Day Fund is at its statutory 6% cap to be transferred to the Retirement Allowance Fund.

Committee Amendment "A" (H-772) proposed to eliminate the original request in fiscal year 1999-00 of \$90,000 and lower the original request for fiscal year 2000-01 from \$60,000 to \$45,000.

The fiscal year 2000-01 appropriation would be used by the Maine Center for the Blind and Visually Impaired, in conjunction with the Maine Public Broadcasting Corporation, to fund a program, Maine Airs, that would have daily and weekly newspapers read for listening by the more than 12,000 residents of the State who are print-disabled.

This amendment also proposed to clarify that this funding is provided on a one-time basis and would have required the Department of Labor to report back to the joint standing committee of the Legislature having jurisdiction over appropriations and financial affairs on the status of the program.

Enacted Law Summary:

Private and Special Law 1999, chapter 92 provides a one-time General Fund appropriation of \$45,000 in fiscal year 2000-01 for the Department of Labor to establish an audio information service through the Maine Center for the Blind and Visually Impaired for people who are blind or visually impaired and other people in the State who are unable to access printed information due to a disability. The Department of Labor is also required to submit a report to the joint standing committee of the Legislature having jurisdiction over appropriations and financial affairs on the status of the Maine Airs program by February 2, 2001.

Committee Amendment "A" (H-813) proposed to replace the bill. It proposed to amend several sections in the Maine Revised Statutes, Title 38 relating to revenue from fines, forfeitures and penalties that are dedicated to several funds within the Department of Environmental Protection. Those revenues would have accrued to the General Fund effective July 1, 2001.

This amendment also proposed to require the Commissioner of Administrative and Financial Services to report to the joint standing committee of the Legislature having jurisdiction over appropriations and financial affairs by December 1, 2000 with a listing of all dedicated fines, forfeitures and penalties and implementing legislation to credit those dedicated revenues to the General Fund. The amendment also proposed to allow the commissioner to exclude from the legislation certain dedicated fines if a justification was included in the report for each fine, forfeiture or penalty excluded.

Senate Amendment "A" to Committee Amendment "A" (S-750) proposed to reduce the General Fund appropriation request from \$85,000 to \$50,000 in fiscal year 2000-01 and clarify that this one-time funding is pass-through money that can not be used for administrative costs. House Amendment "N" to Committee Amendment "A" (H-1158) proposed to add a new sales tax exemption for pet food.

House Amendment "O" to Committee Amendment "A" (H-1159) proposed to provide for the establishment of the Child-centered Scholarship program to provide 1,000 scholarships per year of \$3,000 each to families of children making less than \$25,000 per year living in school districts that rank in the lowest 20th percentile for academic performance if those children attend schools other than the local public school.

House Amendment "P" to Committee Amendment "A" (H-1160) proposed to eliminate the Maine Learning Technology Endowment, the Maine Learning Technology Reserve and the amount up to \$20,000,000 that was designated to be set aside in the reserve for the endowment from excess revenues and unappropriated surplus.

This amendment also proposed to remove language that authorizes the Maine Governmental Facilities Authority to issue securities to finance the construction of the psychiatric treatment facility and replaces that financing with a General Fund appropriation that is offset with the amounts appropriated for the Maine Learning Technology Endowment.

This amendment also proposed to implement the full indexing of the individual income tax brackets sooner beginning in tax year 2001.

House Amendment "Q" to Committee Amendment "A" (H-1162) proposed to deappropriate \$20,000,000 from the Maine Learning Technology Endowment and instead uses those funds to establish the Maine Small Employer Health Insurance Program. Under the program, which would have taken effect June 30, 2001, employers with more than 5 and fewer than 26 employees would have been able to obtain health insurance for their employees through the program. The employers would pay 1/2 of the cost of the employee health insurance and the program would pay the remaining cost.

House Amendment "R" to Committee Amendment "A" (H-1164) proposed to remove the emergency preamble and emergency clause. This amendment proposed to make a number of adjustments to the majority report to comport with the intent of the signers of that report.

It also proposed to shift certain appropriations, allocations and other changes in law from fiscal year 1999-00 to fiscal year 2000-01.

Senate Amendment "A" to Committee Amendment "A" (S-716) proposed to raise the school construction debt service limit from \$84,000,000 to \$88,000,000 in 2005.

Senate Amendment "A" to Committee Amendment "B" (S-718) proposed to provide funds to establish one Assistant District Attorney position to assist in the prosecution of juvenile crimes and domestic violence cases.

Senate Amendment "B" to Committee Amendment "A" (S-717) proposed to provide funds to establish one Assistant District Attorney position to assist in the prosecution of juvenile crimes and domestic violence cases.

Senate Amendment "C" to Committee Amendment "A" (S-725) proposed to direct the State Controller to transfer \$5,000,000 from excess General Fund revenue to the Department of Education for use in school renovation projects.

Senate Amendment "D" to Committee Amendment "A" (S-726) proposed to strike the Maine Learning Technology Reserve, create a School Construction Reserve and also direct the State Controller to transfer any excess General Fund reserve to the Department of Education to buy down the debt on school construction.

Senate Amendment "E" to Committee Amendment "A" (S-727) proposed to provide a sales tax exemption for electricity used in commercial agricultural production, commercial fishing or commercial aquacultural production beginning July 1, 2000.

Senate Amendment "F" to Committee Amendment "A" (S-728) proposed to remove language that establishes the Maine Learning Technology Endowment and the Education Technology Reserve. It proposed to include a General Fund appropriation to provide funding for the psychiatric treatment facility and remove language that authorizes the Maine Governmental Facilities Authority to issue securities to finance the construction of the facility. It also proposed to establish state death benefits for law enforcement officers killed in the line of duty and provide funds to reduce the unfunded liability of the Maine State Retirement System.

Senate Amendment "G" to Committee Amendment "A" (S-729) proposed to:

- 1. Strike the appropriation and allocation sections from the majority report and replace them with new appropriation and allocation sections.
- 2. Remove Parts D, R to W, GG to WW, AAA, FFF, GGG, LLL, NNN, SSS to XXX and BBBB from the majority report.
- 3. Add the following Parts to the majority report:

PART EEEE proposed to specify the General Purpose Aid for Local Schools actual education cost certification and appropriation levels for fiscal year 2000-01 as required by the Maine Revised Statutes, Title 20-A, section 15605.

PART FFFF proposed to provide a sales tax exemption for electricity used in commercial agriculture, fishing or aquaculture beginning July 1, 2000.

PART GGGG proposed to provide an income tax deduction for public and private pension income to the extent that the pension income, together with social security benefits and railroad retirement benefits, does not exceed \$6,000 in tax years beginning in 2000, 2001 or 2002; \$8,000 for tax years beginning in 2003 or 2004; and \$10,000 for tax years beginning on or after January 1, 2005. This Part proposed to make no change to the current law that exempts all social security and railroad retirement benefits from state income tax.

PART HHHH proposed to provide for full indexing of the individual income tax brackets for tax years beginning on or after January 1, 2001.

PART IIII proposed to provide an income tax exemption for individuals of up to \$1,500 of net long-term capital gains for tax years beginning on or after January 1, 2001.

PART JJJJ proposed to provide that the personal exemption of the state individual income is the same as the personal exemption for purposes of the federal income tax for tax years beginning on or after January 1, 2001.

PART KKKK proposed to eliminate the prepayment of 1/2 of the next year's tax on telecommunications personal property.

PART LLLL proposed to:

- 1. Require that revenues deposited into the Fund for a Healthy Maine that are less than estimated for programs and services supported by the Fund for a Healthy Maine must be reduced proportionately to their share of the overall fund, except the Medical Care Payments to Providers program.
- 2. Amend the law to eliminate the requirement that the Fund for a Healthy Maine return a working capital advance to the General Fund.
- 3. Provide allocations in 5 areas. It allocates 10% of estimated tobacco settlement revenue to the Trust Fund for a Healthy Maine. The Partnership for a Tobacco-free Maine is funded to create a support system for those who want to quit smoking and for other statewide tobacco interventions. Funds are provided to implement the recommendations of the Substance Abuse Services Commission, and a program is established to improve delivery of and access to quality care for Medicaid recipients. Funding is also provided to cover an anticipated Medicaid shortfall.

PART MMMM proposed to expand the eligibility of the Cub Care program to children who have not attained one year of age. It also proposed to allocate funds from the Fund for a Healthy Maine to the Department of Human Services for fiscal year 2000-01 for that purpose.

PART NNNN proposed to establish a new position of school nurse consultant jointly within the Department of Human Services and the Department of Education. This position will provide statewide nursing leadership for coordinated school health care programs. This Part also proposed to include an allocation to the Department of Education from the Fund for a Healthy Maine for the salary, benefits, operating and start-up costs of an Education Specialist III position to function as the school nurse consultant.

PART OOOO proposed to create the Maine Biomedical Research Program, using a \$10,000,000 allocation from the Fund for a Healthy Maine. Funds are intended to support biomedical research with priority given to research and research technologies with the potential to affect diseases, biomedical mechanisms or conditions that are either caused by or related to tobacco use. A report is due to the First Regular Session of the 120th Legislature concerning ways to share revenue, including royalties, generated by biomedical research funded by this Part.

PART PPPP proposed to expand the supplemental program of the low-cost drugs to Maine's elderly to cover 80% of the cost of generic drugs not covered in the basic program, to institute a catastrophic component whereby the Department of Human Services would establish an annual limit on the total costs to be paid by eligible persons in the program, after which the program must pay 80% of all covered drugs or medications, and to make the low-cost drugs to Maine's elderly program the payor of last resort through a 3rd-party liability recovery process.

PART QQQQ proposed to require the Commissioner of Administrative and Financial Services to attempt to sell or lease the property currently located at the Maine Criminal Justice Academy in Waterville at its fair market value.

PART RRRR proposed to:

- 1. Establish the Equity and Access to Education Technology Fund. The fund is to be used to support the education technology needs of the State's teachers and students. Expenditures from the fund may be made only as authorized by the Legislature. The funding source for the fund will be the unexpended balance from the so-called School and Library Network Project.
- 2. Add maintenance and operating expenses of the ATM Distance Learning network to the allowable uses from funds received by the 0.5% assessment on telecommunications services.
- 3. Provide an Other Special Revenue funds allocation in fiscal year 2000-01 to the Department of Education for the maintenance and network management of the ATM Distance Learning network.

PART SSSS proposed to transfer interest on investment earnings from the Fund for a Healthy Maine to the General Fund.

PART TTTT proposed to establish state death benefits for law enforcement officers killed in the line of duty.

PART UUUU proposed to:

- 1. Establish the transfer to the Retirement Allowance Fund as the first priority of the surplus revenue at the close of each fiscal year and increase the amount of that transfer to 1/2 the surplus revenue. The Maine Rainy Day Fund would receive 1/2 of the balance of the excess after the Retirement Allowance Fund transfer, or 1/4 of the surplus revenue. A similar change in the priority of claims for certain increases of General Fund revenue estimates is also included in this Part.
- 2. Establish a Debt Avoidance Fund that would receive the remainder of the excess revenue after the transfers to the Retirement Allowance Fund and the Maine Rainy Day Fund. The Debt Avoidance Fund is established to avoid the issuance of bonds authorized by the voters but as yet unissued.

PART VVVV proposed to include several initiatives related to long-term care, including amendments to address labor force issues in the nursing field, develop standardized contracts, provide default licensing for new applicants, reflect current costs in the principles of reimbursement, and change the duration of licensing and the surveys required of providers of long-term care services. It also proposed to require a report on ways to expand delegation of the National Fire Protection Association Life Safety Code and provide General Fund appropriations of \$5,000,000 in fiscal year 2000-01 for long-term care initiatives.

Senate Amendment "H" to Committee Amendment "A" (S-730) proposed to limit reimbursement under the business equipment tax reimbursement program for eligible property first placed in service in the State, or constituting construction in progress commenced in the State, after April 1, 2001 to 90% of the property taxes paid on that property.

Senate Amendment "I" to Committee Amendment "A" (S-731) proposed to exclude from eligibility for reimbursement for property taxes paid on business equipment personal property located in a tax increment financing district that is designated after July 1, 2000.

Senate Amendment "J" to Committee Amendment "A" (S-732) proposed to deappropriate \$30,000,000 from the Maine Learning Technology Endowment and deappropriate \$2,209,294 from the General Purpose Aid

for Local Schools program. The amendment also proposed to provide an additional General Fund appropriation of \$9,500,000 for General Purpose Aid to Local Schools and provide an additional General Fund appropriation of \$22,709,294 for school renovations. The amendment also proposed to establish the education hardship cushion for fiscal year 2000-01.

Senate Amendment "K" to Committee Amendment "A" (S-733) proposed to provide that roll call votes of the Legislature be available to the public via the Internet within one hour of the roll call.

Senate Amendment "L" to Committee Amendment "A" (S-734) proposed to increase the State's share for health insurance premiums for retired educators from 30% to 35% on July 1, 2001.

PART N proposed to create the Human Leukocyte Antigen Screening Fund, utilizing a voluntary income tax contribution checkoff. It also proposed to provide a one-time \$250,000 allocation from the Fund for a Healthy Maine for first-year funding of the Human Leukocyte Antigen Screening Fund.

This amendment also proposed to add a fiscal note.

Committee Amendment "B" (H-942), the minority report of the Joint Standing Committee on Appropriations and Financial Affairs, would have replaced the bill.

PART A of this amendment proposed to require that revenues deposited into the Fund for a Healthy Maine that are less than estimated for programs and services supported by the Fund for a Healthy Maine must be reduced proportionately to their share of the overall fund, except the Medical Care - Payments to Providers program.

PART A also proposed to amend the law to eliminate the requirement that the Fund for a Healthy Maine return a working capital advance to the General Fund.

PART A also proposed to provide allocations in 5 areas. It proposed to allocate 10% of estimated tobacco settlement revenue to the Trust Fund for a Healthy Maine. The Partnership for a Tobacco-free Maine is proposed to be funded to create a support system for those who want to quit smoking and for other statewide tobacco interventions. Funds are proposed to implement the recommendations of the Substance Abuse Services Commission, and a program is proposed to be established to improve delivery of and access to quality care for Medicaid recipients. Funding is also proposed to cover an anticipated Medicaid shortfall.

PART B proposed to establish and fund the position of school nurse consultant within the Department of Human Services and the Department of Education. The school nurse consultant's duties would include acting as a liaison to school health care providers and policy-setting groups; providing health care, nursing, policy and legal information regarding school nursing, school health care programs and professional development; promoting staff development, nursing excellence and optimal health of school children.

PART C proposed to create the Maine Biomedical Research Program, using a \$10,000,000 allocation from the Fund for a Healthy Maine. Funds are proposed to support biomedical research with priority given to research and research technologies with the potential to affect diseases, biomedical mechanisms or conditions that are either caused by or related to tobacco use. A report is proposed to be due to the First Regular Session of the 120th Legislature concerning ways to share revenue, including royalties, generated by biomedical research funded by this Act.

PART D proposed to expand the supplemental program of the Low-cost Drug to Maine's Elderly to cover 80% of the cost of generic drugs not covered in the basic program, to institute a catastrophic component whereby the Department of Human Services would establish an annual limit on the total costs to be paid by eligible persons in the program, after which the program must pay 80% of all covered drugs or medications and make the Low-cost Drugs to Maine's Elderly program the payor of last resort through a 3rd-party liability recovery process.

The amendment also proposed to add a fiscal note.

House Amendment "A "to Committee Amendment "A " (H-964) proposed to remove the emergency preamble and emergency clause. It also proposed to adjust the allocation to the Trust Fund for a Healthy Maine accordingly and remove the requirement that the working capital advance be repaid prior to May 1, 2000.

While this bill was indefinitely postponed, allocations from the Fund for a Healthy Maine were included in Public Law 1999, Chapter 731, Part GG to Part VV and Part HHHH-3.

LD 2555 proposed to require that revenues deposited into the Fund for a Healthy Maine that are less than estimated for programs and services supported by the Fund for a Healthy Maine must be reduced proportionately to their share of the overall fund, except the Medical Care - Payments to Providers program.

The bill also proposed to create a program, administered by the Department of Human Services, Bureau of Health to encourage and assist primary and secondary schools to develop comprehensive school health education and school health services that, in coordination with a program of community health initiatives, would reduce the rates of tobacco addiction, physical inactivity, poor nutrition and tobacco-related chronic disease.

The bill further proposed to create a similar program for communities that develop comprehensive community health interventions and health services that reduce the rates of tobacco addiction, physical inactivity, poor nutrition and tobacco-related chronic disease.

Sections 4 and 5 proposed to make allocations from the Fund for a Healthy Maine for a comprehensive health effort that encourages state agencies, communities, schools and health care providers to work together to address tobacco-related chronic disease in Maine.

While this bill was reported Ought Not to Pass, allocations from the Fund for a Healthy Maine were included in Public Law 1999, Chapter 731, Part GG to Part VV and Part HHHH-3.

LD 2568 proposed to provide immediate relief to the trucking industry in Maine by suspending the excise tax of 23ϕ per gallon imposed on distillates, also known as "diesel fuel." The suspension would have been for 30 days, but may have been extended for 15 more days if the Governor determined that the retail price of distillates had not decreased below \$1.50 per gallon. The Department of Administrative and Financial Services, Bureau of Revenue Services would be required to provide notice of the provisions of this bill to suppliers and retail dealers of distillates.

The bill also proposed to transfer from the General Fund to the Highway Fund the amount of revenue lost due to the suspension of the distillates excise tax, as determined by the Bureau of Revenue Services.

This bill was jointly referred to the Joint Standing Committee on Appropriations and Financial Affairs and the Joint Standing Committee on Transportation.

Committee Amendment "A" (H-901) proposed to change the bill to a resolve. It proposed to establish a rebate for qualifying diesel fuel purchases made in this State during the period from February 1, 2000 to March 15, 2000. The rebate would have been equal to the 23¢-per-gallon excise tax on diesel fuel.

It also proposed to add an appropriation section and a fiscal note to the resolve.

House Amendment "A" (H-912) proposed to strike the emergency preamble and clause and change the fiscal year for which the appropriation is provided.

House Amendment "B" to Committee Amendment "A" (H-968) proposed to change the source of the funds for the rebate of the excise taxes on diesel fuel from the General Fund to the Highway Fund.

Specifically, the bill proposed to provide \$100,000 for professional development in special education and alternative education, \$39,794 for an additional special education teacher and \$75,000 for tutors and short-term substitutes necessary to address the educational needs of students when the student population is at maximum capacity.

If matching funds were not received, the funds appropriated in the bill would revert to the General Fund. The amendment also proposed to change the appropriation to the Department of Economic and Community Development for the Southern Maine Economic Development District and proposed that the district submit a plan for the use of the funds to the department, which has approval and oversight authority.

Senate Amendment "A" (S-759) proposed to add an appropriation of \$200,000 in fiscal year 2000-01 to the bill to provide funds to the Department of the Attorney General to be used to respond to the complaint filed by New Hampshire against Maine in the United States Supreme Court seeking to resolve the dispute regarding the boundary between Maine and New Hampshire and would require the Attorney General to report to the joint standing committee of the Legislature having jurisdiction over appropriations and financial affairs concerning expenses incurred.

Senate Amendment "B" (S-796) proposed to add an appropriation of \$200,000 in fiscal year 2000-01 to the bill to provide funds to the Department of the Attorney General to be used to respond to the complaint filed by New Hampshire against Maine in the United States Supreme Court seeking to resolve the dispute regarding the boundary between Maine and New Hampshire and would require the Attorney General to report to the joint standing committee of the Legislature having jurisdiction over appropriations and financial affairs concerning expenses incurred.

Enacted Law Summary:

Private and Special Law 1999, chapter 99 provides a General Fund appropriation of \$50,000 to the Department of Economic and Community Development for the Southern Maine Economic Development District to match an anticipated federal grant of \$50,000 in fiscal year 2000-01 to evaluate the United States Naval Shipyard in Kittery, Maine to determine the potential use by private sector industries for nondefense-related projects. Chapter 72 was enacted as an emergency measure effective March 31, 2000.

LD 2683 proposed the following:

PART A proposed to modify the Economic Recovery Program administered by the Finance Authority of Maine by making the programs more flexible to meet the needs of Maine businesses.

The modifications would have allowed the Finance Authority of Maine to establish repayment terms reflective of the risk of a particular loan by allowing the authority to use financing techniques such as obtaining repayment based on the performance of the company through royalty payments, repayment tied to actual cash flow or through a convertible debenture, which allows the debt to be converted to equity in the company.

It also proposed to repeal the requirement that an applicant must have been turned down by all other lenders. This would have allowed the Finance Authority of Maine to participate in financing packages with commercial lenders and other economic development agencies.

PART B proposed to modify the Maine Economic Development Venture Capital Revolving Investment Program Fund administered by the Finance Authority of Maine.

It proposed to clarify that capitalization of the fund may come from sources other than direct appropriations.

It proposed to amend the law to allow the authority to invest in newly established venture capital funds that show evidence of likelihood of success by the manager's background and other factors, as well as established venture capital funds.

It proposed to amend the law to require that a private venture capital fund receiving an investment from the authority certify to the authority that it would undertake to invest in an amount equal to the authority's investment in Maine manufacturers or Maine companies that are involved in the development or application of advanced technologies that provide a product or service that is sold or projected to be sold predominantly outside the State or that otherwise bring capital into the State.

It proposed to repeal the prohibition on an officer or employee of a private venture capital firm from participating in a decision on a project in which the officer or employee has a direct financial interest. It proposed to replace that provision with a requirement that the authority's contract with the private venture capital firm give the authority rights and access equal to all other investors in the venture capital firm.

It proposed to amend the law to allow the venture capital funds receiving an investment to use up to 4% annually of the funds received from the authority for administrative purposes.

It proposed to repeal a provision that requires that a private venture capital firm invest 80% of all its funds in a business that is eligible for the Maine Seed Capital Tax Credit.

It proposed to add a requirement that private venture capital funds that receive an investment from the authority report on the amount of funds invested in Maine manufacturers or Maine companies that are involved in the

development or application of advanced technologies, that provide a product or service sold or projected to be sold predominantly outside the State or that otherwise bring capital into the State.

It proposed to transfer funds that have revolved back into the Economic Recovery Program Fund to the Maine Economic Development Venture Capital Revolving Investment Program Fund.

PART C proposed to appropriate funds to the Department of Economic and Community Development for an information technology manager to work with the Maine Business Works program.

PART D proposed to appropriate funds to the Department of Economic and Community Development to allow the department to contract with a field representative to serve in a currently underserved and economically depressed area.

PART E proposed to direct the Maine Rural Development Council to provide advocacy for the social and economic needs of rural Maine communities and to develop community capacity building projects, and it proposed to appropriate \$125,000 to the council. The Maine Rural Development Council is a quasi-independent state agency whose members are representatives from intergovernmental and interagency associations concerning rural development issues.

PART F proposed to establish the Maine Microenterprise Initiative Fund in the Department of Economic and Community Development for grants to community-based organizations providing training and technical assistance to microenterprises. The department would be required to adopt rules to establish grant application procedures and criteria. The bill proposed to appropriate from the General Fund a nonlapsing \$1,000,000 to the Maine Microenterprise Initiative Fund.

PART G proposed to establish the Regional Economic Development Assistance Fund in the Department of Economic and Community Development for grants to nonprofit community organizations providing local or regional economic development programs. The bill proposed to appropriate \$500,000 from the General Fund to the fund.

PART H proposed to amend the law creating the Agricultural Products Utilization Commission by authorizing the commission to identify issues related to the development of agriculturally derived fuel industries in Maine, to identify agriculturally derived fuel development programs and to analyze the potential for agriculturally derived fuel production in Maine. It also proposed to add the chief executive officer of the Finance Authority of Maine to the commission membership and add a requirement to report to the joint standing committee of the Legislature having jurisdiction over business and economic development matters.

PART I proposed to appropriate funds to the Maine Technical College System for a pilot program for the Aroostook County Machine Tool Program.

While this bill was reported Ought Not to Pass, General Fund appropriations totaling \$1,500,000 in fiscal year 2000-01 were included in Public Law 1999, Chapter 731, Part VVV to enhance economic development in the State of Maine.
