PART G

3 Sec. G-1. Fund for a Healthy Maine; adjustment to allocations; fiscal year 2010-11. Notwithstanding the Maine Revised Statutes, Title 22, section 1511, 4 subsection 12, for fiscal year 2010-11 only, if actual revenue collections for the fiscal 5 year are less than the approved legislative allocations, the State Budget Officer shall 6 7 review the programs receiving funds from the Fund for a Healthy Maine and shall adjust the funding in the All Other line category to stay within available resources. These 8 9 adjustments must be calculated in proportion to each account's allocation in the All Other 10 line category in relation to the total All Other allocation for fund programs based on allocation balances remaining in each account on March 1, 2011. Notwithstanding any 11 other provision of law, the allocation for the identified amounts may be reduced by 12 financial order upon the recommendation of the State Budget Officer and approval of the 13 14 Governor.

17 This Part changes the method to be used by the State Budget Officer to ensure that 18 allocations stay within existing resources for Fund for a Healthy Maine programs. For 19 fiscal year 2010-11 only, if actual revenue collections are less than approved legislative 20 allocations, the State Budget Officer is required to adjust funding and the adjustment 21 must be a proportionate calculation based on All Other allocation balances remaining on 22 March 1, 2011.
