## §5604. Monetary sanctions

**1. Designation.** A monetary sanction authorized by law and imposed by the court for a civil violation may be designated a "fine," "penalty," "forfeiture," "surcharge" or "assessment" or may be designated by another similar term.

**2.** Civil violation. Use of the terminology under subsection 1 in describing a monetary sanction for a civil violation does not limit or prohibit the application of Title 17-A, section 4-B, subsection 3. [PL 2003, c. 452, Pt. X, §1 (NEW); PL 2003, c. 452, Pt. X, §2 (AFF).]
