"Turning the Tide for the Multicultural Population In Maine" by Passing LD1239

My name is Mufalo Chitam. I am here to testify in <u>SUPPORT of LD 1239</u> on behalf of the board and 77 members of <u>Maine Immigrants' Rights Coalition</u> (MIRC) with a commitment to advancing and defending the rights of immigrants.

Our mission is to improve the legal, social and economic conditions experienced by Maine's immigrants – enhancing their lives while strengthening Maine – through advocacy, information sharing and collaboration both through and among our member organizations.

Maine has seen a growth of immigrants in the last 10 years but needs to grow infrastructure at the same rate in order to support their economic and social integration. Maine has almost 10,000 multicultural college and university students, many from out of state, and it has over 600 high skilled H1B visa workers, many are in our IT and medical sectors.

MIRC strongly believes that immigrants need to be developed intentionally and systematically. Prior to the pandemic Maine had been experiencing historic low unemployment rates of under 4% but had a problem of underemployment.

LD 1239 aligns with the MIRC vision of building the capacity of immigrants and passing this bill will address the underemployment problems in our new Mainers population and will encourage our multicultural students to remain in Maine after graduating.

This bill is important now, especially at this monumental time. If Maine is to thrive, immigrants must be able to get support services like *"Career Advancement and Navigation Specialist"* that help to speed their integration in the community and improve their work/school readiness.

Passing LD 1239 will help to open up more employment opportunities across many other untapped sectors for multicultural populations thereby advancing opportunity and economic equity for Maine's Black, Indigenous, and communities of color, as well as for recent immigrants to Maine.

In the last 12 months due to COVID19, MIRC has taken a lead role in advocating for benefits that will help address disparities in the system. WE are leading the way toward a future Maine that is built on principles of racial and social justice, economic security, and inclusion.

Today we ask this committee to work with us by passing this bill to ensure that Maine can compete in a growing multicultural workforce and economy.
