During the public hearings on LD 761 and LD 1152, I was asked three questions:

- 1) Is there data on the average student loan debt carried by Maine community college students?
- 2) Is more detailed information available, such as debt load by school and debt load carried by students who do not finish a degree program?
- 3) Do you have any information on how many students transfer into the community college system from other schools?

The information on the next two pages seeks to answer the questions around student loan debt carried by our students.

As for transfer information, I looked at enrollment the last two fall semesters:

- Fall 2019: 3,379 out of 17,327 students in credit courses were identified as a transfer-in student when ٠ they first enrolled in a Maine community college.
- Fall 2020: 3,237 out of 15,948 students in credit courses were identified as a transfer-in student when • they first enrolled in a Maine community college.

I hope this information is helpful as you seek to better understand student debt and its impact on Maine's college students. I will be available for the work session on Thursday, April 29th.

Loan data by college for <u>all borrowers</u> (graduates and non-graduates) as well as for graduates only. Because this is reported as median debt, we are unable to get a system-wide average from the data. Please be advised that students bring their debt from previous college attendance with them to the college they are currently attending.

Median Loan Debt: This is the median loan debt accumulated at the institution by all student borrowers of federal loans who separate (i.e., either graduate or withdraw) in a given fiscal year, measured at the point of separation. More specifically, the measure represents the sum of all undergraduate federal loans over students' college education at the institution for which the median debt is reported for —e.g., if a student receives a federal loan for \$2,000 for each of eight semesters at one institution, their cumulative debt is recorded as \$16,000 for that institution.
