TESTIMONY IN SUPPORT OF L.D. 51

An Act to Restore Religious and Philosophical Exemptions to Immunization Requirements by Barbara Smith, MT(ASCP)

April 3, 2023

Good day Senator Rafferty, Representative Brennan and distinguished members of the Education and Cultural Affairs Committee.

My name is Barbara Smith and I am testifying in support of L.D. 51. I reside in Old Town. I worked in a microbiology lab for 50 years and vaccinated my children. I support LD 51.

MY reasoning comes from a lot of research concerning vaccines for several years. Many things below have bothered me.

- 1. Vaccine ingredients in some vaccines: aluminium, mercury, monosodium glutamate, polysorbate 80 that crosses blood brain barrier, formaldhyde, human abortion cells, animal tissue and much more.
- 2. 1986 vaccine injury act where vaccine manufactures are not liable for injury or death.
- 3. In 1970 1 in 10,000 children had autism and now it's 1 in 36 (CDC).
- 4. In the 1940's, only the DPT and smallpox vaccines were given. Now there are at least 72 doses given and more are being added. There are plans to add mRNA technology to some vaccines.
- 5. The first vaccine is Hepatitis B on first day of life. It isn't needed if the mother tested negative for Hepatitis.
- 6. A one day old baby's immune system is not fully developed at birth so of what value are the Hepatitis vaccines to the newborn?
- 7. Vaccinated mothers can't pass on immunity through breast milk.
- 8. Vaccines do not get a double blind placebo trial with a saline placebo. The placebo that is used is often another vaccine.
- 9. Several non CDC trials have proven that non vaccinated kids are healthier than vaccinated.
- 10. One study to see if the MMR was related to autism found that it was in some boys if given before 3, but they covered it up.
- 11. If you look at the history of polio and small pox you will find that the cause was poor sanitation and DDT.
- 12. Our government agencies are tied in with the pharmaceutical industry. The FDA gets 45 % of their budget from the pharmaceutical industry.
