In doing so we have found that our work in Maine is hampered by the lack of a definition in statute of "environmental justice populations". LD 1621 directs the Department of Environmental Protection to define "environmental justice populations". While it is well recognized that there are populations that bear the brunt of the climate crisis in myriad ways we need a legal definition reflecting this and thus allowing fair and equitable considerations and engagement by the DEP as a start.

MCAN supports LD 1621. We see the necessity of this bill toward ensuring meaningful participation by environmental justice communities in Maine. We believe that everyone needs to be involved if we are to combat the climate crisis.
