Since that acquisition, the CUD has invested several millions of dollars in maintaining and upgrading the water and wastewater infrastructure in Caribou. This investment has improved service, streamlined operations, and expanded capacity of both systems while maintaining some of the most affordable rates in the State.

The CUD Trustees represent a diverse cross section of the City, with three of the members having over 15 years' experience each on the Board. Since the acquisition of the Water Division, the CUD Trustees and staff have transformed the District from two reactive, dysfunctional companies into a progressive, proactive, cohesive organization. Our neighbors for the next 3 miles have only a wireless option – I consider them unserved as well.

The CUD would be the best entity to build, own, and operate a public, open fiber network to bring true broadband access to everyone in Caribou. We are the City's Utility District, we have a proven track record of dependable, affordable service and we have extensive project execution experience. At our recent local public hearing we received much favorable input and support for our pursuit of this project.
