Hello, Senator Curry, Representative Gere, and Members of the Joint Standing Committee on Housing and Economic Developpent.

My name is Laura Mitchell. I am the Executive Director of the Maine Affordable Housing Coalition. MAHC is a nonprofit with 140 member organizations working to create and preserve affordable homes for all Maine people.

As you know, Maine is under extreme pressure to provide housing that is safe and affordable for all Maine people. Maine people are having to choose between food, medicine or housing, are living outside through cold winters, or are aging without options and are stuck in housing they can't afford to keep up. Businesses are struggling to fill positions and grow because housing isn't affordable for their workforce. **More housing is the solution to all these things.** 

MAHC supports the intent of LD161 to review and modernize Maine's decades old Subdivision Laws that are currently adding unnecessary red tape, time and cost to building vital affordable housing in Maine. The State commissioned a housing study with HR&A in 2023 that stated that Maine needs 80,000 new homes by 2030. This year, HR&A shared a roadmap to meeting that goal. Streamlining processes was HR&A's number one priority and within that, specifically raising the threshold for subdivision review.

LD161 takes a direct step toward reviewing and understanding the complexity and consequences of this out of date process and provides an opportunity for experts to define a more streamlined review that can achieve current goals for affordable housing, fiscal health, and quality of life.

With the launch of the new Maine Office of Community Affairs (MOCA) now complete, and MOCA's role as a liaison between towns and the state on planning, land use, and municipal review of housing and other development projects, MAHC would suggest that this resolve point toward MOCA as the State body that convenes this group.
