COMMITTEE AMENDMENT “ ” to S.P. 216, L.D. 529, “An Act To Restore the
10 Maine Center for Disease Control and Prevention Cystic Fibrosis Assistance Program”

Amend the bill by striking out the title and substituting the following:

12

**'Resolve, To Direct the Department of Health and Human Services To Review the
13 Needs of Persons with Low-incidence Health Conditions'**

14

Amend the bill by striking out everything after the title and inserting the following:

15

**'Sec. 1. Department of Health and Human Services to review the needs of
16 persons with low-incidence health conditions. Resolved:** That the Department of
17 Health and Human Services shall undertake a review of the needs of persons with low-
18 incidence health conditions. The review required by this section must:

19

1. Identify common low-incidence health conditions that occur in children, including,
20 but not limited to, cystic fibrosis, cerebral palsy, Lowe syndrome, muscular dystrophy,
21 spina bifida, cleft lip and cleft palate, chromosomal disorders such as Down syndrome and
22 neurological disorders;

2. Identify the conditions identified under subsection 1 that require services or supports
24 into adulthood and what the scope of the needs may be;

25

3. Identify the conditions identified under subsection 1 for which funds are currently
26 provided through the children with special health needs program within the Department of
27 Health and Human Services, Maine Center for Disease Control and Prevention, including,
28 for each condition, the source of the funding and the amount of expenditures;

4. Identify the conditions identified under subsection 1 for which funds are not
30 currently provided through the children with special health needs program within the
31 Department of Health and Human Services, Maine Center for Disease Control and
32 Prevention;

5. Describe the unmet needs of persons with each condition identified under subsection

The department shall develop a plan to address the unmet needs described in subsection 5 and to improve the ability of the children with special health needs program within the Department of Health and Human Services, Maine Center for Disease Control and Prevention to meet those needs.

Sec. 2. Report. Resolved: That the Commissioner of Health and Human Services shall present the findings of the review and recommendations of the department pursuant to section 1 to the Joint Standing Committee on Health and Human Services no later than January 15, 2022. The Joint Standing Committee on Health and Human Services is authorized to report out legislation relating to the report to the Second Regular Session of the 130th Legislature.'

Amend the bill by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively.

SUMMARY

This amendment, which is the unanimous report of the committee, replaces the bill with a resolve. It directs the Department of Health and Human Services to conduct a review of the needs of persons with low-incidence health conditions and develop a plan to address the unmet needs of those persons. It directs the department to submit its report to the Joint Standing Committee on Health and Human Services no later than January 15, 2022 and authorizes the committee to report out legislation relating to the report to the Second Regular Session of the 130th Legislature.
