My motivation for speaking to you this morning arises largely from a desire to remember a family friend who had multiple disabilities, and whose death was, to my knowledge, never fully investigated or explained. Bradley was nonverbal, required assistance for basic skills such as eating and dressing, and required round the clock monitoring for his uncontrolled seizure disorder. Following heroic efforts by his parents to find an appropriate living situation for him when they finally recognized they were no longer capable of providing the intense support he required, Brad began living away from his family for the first time in his life. Several months later he was found dead in his bedroom. It was a tragic, and perhaps, preventable death. Needless to say, it was devastating for his family.

When I talked to Bradley's mother at his memorial service, I was amazed at her strength and lack of bitterness at the loss of her son. As she was brave enough to share publicly at the time with others, her only wish was that something like this would never again have to be experienced by another family, and that she might someday know the whole story of the circumstances of Bradley's death.
