After residential treatment then day programing and sober living residence he now lives on his own and has a successful job working in residential recovery. And, while he had to leave Maine because of lack of residential care options we benefited greatly from resources like PRCC. Frankly without their help we would not have made it.

While my son is doing fine and benefitted from our help and the help of PRCC, the addiction crisis continues in Maine and, in much of Maine, needed resources like PRCC are not available.
