Dear Board,

Thank you for taking the time to read my testimony. I have been documenting the Covid19 pandemic for the past two years; myself, and millions of other people. What we've learned, shared, and collaborated would shock, and dismay the world.

It is a betrayal to the STATE OF MAINE, and in my humble opinion, a Crime Against Humanity if this board, or any **other MANDATES** a vaccination that is regarded as a potential BIOWEAPON, a KNOWN but not yet proven in a court of law accusation against Gates, Pfizer, Moderna, the CDC, Fauci, among others.

<u>Senator Rand Paul openly accused Fauci on November 4, 2021</u>, during a senate hearing on gain-of function research in association with the Wuhan Lab in China¹. A claim which Fauci denied.

Recently on January 11, 2022, <u>Project Veritas dropped alarming disclosure documents</u> from Major Joseph P. Murphy, former DARPA, the Defense Advanced Research Project Agency, fellow who clearly states his concerns.

"I'm unsure whether the significance of what I communicated is understood by those that received the report. Decisions with regards to the vaccines do not appear to be informed by analysis of the documents. The main points being that SARS-CoV-2 matches the SARS vaccine variants the NIH-EcoHealth program was making in Wuhan; that the DOD rejected the program proposal because vaccines would be ineffective and because the spike proteins being inserted into the variants were deemed to dangerous (gain-of-function); and that the DOD now mandates vaccines that copy the spike protein previously deemed too dangerous. To me, and to those who informed my analysis, this situation meets no-go or abort criteria with regards to the vaccines until the toxicity of the spike protein can be investigated."

Major Murphy is not the only canary in the coal mine. People like Robert Malone, one of the inventors of the mRNA technology has been openly opposed to the vaccination program, and mandates. In a speech given at the Global Covid Summit on December 12, 2021, Malone offered his reasoning.

Before you vaccinate your child, which is irreversible and potentially permanently damaging, find out why 15,000 physicians and medical scientists around the world signed a declaration publicly declaring that healthy children should NOT be vaccinated for COVID-19...

The first is that a viral gene will be injected into your children's cells. This gene forces your child's body to make toxic spike proteins. These proteins often cause permanent damage in children's critical organs, including

Their brain and nervous system

Their heart and blood vessels, including blood clots

Their reproductive system, and

This vaccine can trigger fundamental changes to their immune system. The most alarming point about this is that once these damages have occurred, they are irreparable

You can't fix the lesions within their brain You can't repair heart tissue scarring


You can't repair a genetically reset immune system, and This vaccine can cause reproductive damage that could affect future generations of your family

The second thing you need to know about is the fact that this novel technology has not been adequately tested.

We need at least 5 years of testing/research before we can really understand the risks

Shocking, I know. Yet what's more concerning is the media and governments response to people like Malone. Instead of taking him and the 15,000 physicians, and scientists concerns seriously, they fact checked him, and labeled him a misinformationist. Most major mainstream publications posted hit pieces filled with character assassinations, minimization of concerns, and told the world there is nothing to worry about here. mRNA vaccination is effective and safe. A bold statement for a novel mRNA technology that doesn't have a history of safety or efficacy. A technology that Prizer's own documentation shows 9 pages of adverse reactions, 10% chance of miscarriage, and 3% risk of death, yet received a favorable rating.

In fact, the CDC's own early warning system is a red flag, figuratively and literally, that something is not right. As of January 7, 2022 there have been **21,955 deaths** reported after getting injected with this safe, **new tech that is leading the revolution in medicine**.



In case you missed it, it bears repeating.

21,955 deaths included in the total list of **1,894,633** adverse events reported through the CDC VAERS system. For comparison,

- <u>In 1937 after 100 deaths from the new drug Elixir Sulfanilamide</u>, an antibiotic, it was immediately removed from the market. Done. They were not taking any risks.
- In 1955, over 250 cases of Polio were associated with a live polio vaccination resulting in many cases of paralysis, and it was recalled immediately after the cases were detected.
- The HAEMOPHILUS B CONJUGATE VACCINE (HIBV), is the second largest vaccine with reported deaths of only 1786 to VAERS over the course of 34 years.

According to the CDC, the VAERS reporting system was developed specifically to detect, and prevent vaccination injuries. Yet our adverse reaction numbers keep going up, and now instead of stopping to address our safety concerns, our government wants to force inject everyone including our children, despite expert testimonials asking us to do otherwise.

In Maine, at the start of the vaccination program, <u>661 CMS recipients died of Covid within 28 days of receiving the vaccination</u>. That's more deaths than the entire year of 2020 when the pandemic was at its height, and we were considered the most vulnerable. These patients, according to Dr. McCullough in his testimony before the court in

attempt to stop mandates against health workers, did not have any serious conditions prior to the onset of the vaccination.


Maine CDC Director, Nirav Shah's response to 661 people in Maine dying within 28 days of getting vaccinated was "VAERS researchers at the CDC study the data, and if or when they see a concerning signal use it as a basis to conduct deeper, more rigorous epidemiological studies to determine whether that signal is in fact concerning or whether that signal is a false association."


When pushed, repeatedly by Attorney Ron Jenkins to comment on if he thought this signal was an indicator to investigate, in essence, Shaw said yes, it was a signal, but it didn't warrant stopping the mandates, and they were approved. Now imagine, those numbers reflected upon 5 to 10 year olds. How many deaths would be acceptable?

What's not a false association and is clearly indicated by <u>the CDC's Provisional Deaths records</u> is that only 147 people died with the underlying condition of Covid19 for an average of 18 people per month prior to vaccinations starting in December of 2020.

After vaccinations started, the death toll catapulted to an average of 108 deaths per month, with December 2020 alone registering 165! This data cannot be ignored. It's relevant, and Maine is not the only place to see dramatic increases in Covid deaths after vaccination programs started.

Starting at the end of March of 2021, Taiwan quickly <u>vaccinated their population</u>, <u>and their deaths per month</u> <u>skyrocketed dramatically</u>, see charts below, jumping from less than 2 per month to an average of 238. That's a huge shift.





To me, this is a strong, easy to visualize indicator that something changed in Taiwan's Covid landscape in the Spring of 2021 resulting in more deaths attributed to Covid19. Coincidentally something did.

Thanks to daily death and vaccination reports, we can see this SPIKE came directly after the introduction of the experimental mRNA injections. Couple that with,

- Major Murphy's concerns that the vaccination is a bioweapon,
- Dr. Malone, and other field experts' concerns of potential life changing, and uncorrectable adverse reactions,

NOW, you can imagine a different scenario emerging. One that requires our leaders to act, and start investigations into whistleblower accusations, and the alarming data trends that consistently show a different narrative than what is being sold to the public through mainstream media.

I hope that you dear representative understand that it is your job, paid for by your constituents to go further, to dig deeper, and look at the broader picture not covered by media and talking heads.

At this juncture, there is an unfolding data stream of potentially incriminating evidence being disclosed through many channels that clearly show strong indicators, <u>enough to start litigations</u>, that the vaccination may in fact be a gain-of-function bioweapon which increases covid deaths, heart disease, miscarriage, ect. by virtue of being injected.

Like Major Murphy, "to me, and to those who informed my analysis, this situation meets no-go or abort criteria with regards to the vaccines until the toxicity of the spike protein can be investigated."

Like him, I too am unsure that what I communicated is understood, but I have faith in humanity. I have faith in you to go against the common narrative and stand up for each and every citizen of this state in search of truth.
