## Dear Legislators:

I am writing to affirm my support for LD 867 - An Act To Prohibit Mandatory COVID-19 Vaccinations for 5 Years To Allow for Safety Testing and Investigations into Reproductive Harm.

I see by the latest VAERS report, that of Dec. 24<sup>th</sup>, that 21,002 deaths have managed to get reported since the release of the CoViD-19 vaccine suite. The Harvard study by Ross Lazarus and colleagues in 2011 determined that "Although 25% of ambulatory patients experience an adverse drug event, less than 0.3% of all adverse drug events and 1-13% of serious events are reported to the Food and Drug Administration (FDA)." 21 U.S. Code § 360bbb–3 - Authorization for medical products for use in emergencies

Section C: (c) Criteria for issuance of authorization

The <u>Secretary</u> may issue an authorization under this section with respect to the <u>emergency use</u> of a <u>product</u> <u>only if</u>, after consultation with the Assistant <u>Secretary</u> for Preparedness and Response, the Director of the National Institutes of Health, and the Director of the Centers for Disease Control and Prevention (to the extent feasible and appropriate given the applicable circumstances described in subsection (b)(1)), the <u>Secretary</u> concludes—

that there is no adequate, approved, and available alternative to the <u>product</u> for diagnosing, preventing, or treating such disease or condition;

I declare to you what you should and probably do already know, that many excellent, approved and (were) available (although there was a massive destruction campaign in 2020, including raids on pharmacies): hydroxychloroquine and ivermectin being the two most prominent and proven effective.

Allow me to quote (fair use) from R. F. Kennedy's new book, The Real Anthony Fauci:
