Dear Senator Claxton, Representative Meyer and esteemed committee members,

My name is Todd Dadaleares CHSOS, EMT-B and I'm a resident of Portland. I am strongly opposed to the experimental COVID shots for five year old children. They also denied my religious exemption and "disqualified" me for unemployment benefits. So, I have witnessed first hand the hypocrisy of the COVID-19 policies and the ever-changing storyline. Currently my ex-employer is allowing vaccinated clinicians who tested positive for COVID to come back to work after five days of quarantine-essentially saying that it is now okay to be around patients if you are contagious.
