Since I became a nurse, I've been taking care of people at some of the worst times in their life including those suffering from Covid. The whole time as an unvaccinated registered nurse. However, now I'm being told I can no longer do that, that I am somehow NOW a risk to public safety that I have to choose unemployment or a vaccine. I am not alone. There are a lot of other healthcare workers across the spectrum of roles including doctors, pharmacists, transporters, phlebotomists and the list goes on. In one year, we went from heroes to zeros.
