## Francine Michaels Kennebunk

This is my third amended testimony-I thank you for using this one.

My name is Francine Michaels and I live in Kennebunk Maine and I am writing to Support LD867 to Halt Vax Mandates & Put a Moratorium on Shots for Pregnant Women.

In November of 2020 I got covid-19 and though it was not a pleasant experience, my illness did not require any intervention of medical treatment of any kind.

A few weeks ago I noticed that people were getting their boosters at my work. I had heard about spike proteins resulting from these alleged vaccines and was concerned. Then just last week I noticed that a wave of sickness went through the facility to the point that there were, on my shift, over 25 percent of the people out sick. Seven people in only one week's time were specifically diagnosed with COVID-19. With so many giving in to getting these alleged vaccines, why would the numbers be going up rather than down?
