Letter of Support for LD 171 Bill on Reducing the Risk of Invasive Aquatic Plants Spread

By encouraging commissioners to seek public comment and discuss and harmonize surface use restriction policies, this bill will promote a more unified and effective approach to protecting our lakes from invasive species that will benefit everyone.

Invasive aquatic plants pose a serious threat to our waterways, disrupting natural ecosystems, harming native species, and negatively impacting recreational activities. The proposed bill addresses these challenges head-on by prioritizing key management actions and enhancing interagency cooperation.

I write in strong support of LD171 and urge you to support this bill and take the necessary steps to implement the proposed measures.
