Currently, jury pools in Maine are primarily drawn from voter registration and driver's license records, which may not fully reflect the diversity of the state's population. By broadening the sources used to compile jury lists to include recipients of public assistance benefits, state unemployment compensation, and individuals receiving state income tax forms, LD 338 ensures that jury pools more accurately represent the entire community. This expansion is essential to achieving a jury system that is not only larger but also more balanced and inclusive.
