A comprehensive analysis of Child Care costs for working parents, employers, and government agencies in the State of Maine

There's so much to love about Maine – the lobster, the coastline, Stephen King, just to name a few. Unfortunately, Child Care costs in Maine are *not* one of those things. Families are facing high Child Care costs, and the situation doesn't seem to be improving.

According to a recent report from Child Care Aware of America and a market rate analysis prepared for the Maine Department of Health and Human Services:

• The average annual cost of infant care in Maine is between \$11,960 and \$15,444-that's between \$997 and \$1,188 per month.

Child Care for a 4-year-old can range between \$8,580 and \$13,260 annually, or between \$715 and \$1,020 per month.

These costs can be a significant burden for many families, especially those with lower incomes. The situation is particularly challenging for minimum wage workers who earn just enough to cover the basic necessities of life.

For a family of four earning the median income in Maine (<u>\$114,591</u>), this represents up to 13% of household earnings — nearly double the recommended 7% to budget towards Child Care. While other states may incur higher proportional costs, this still puts a significant strain on many Maine families.

Factors Influencing the Cost of Maine Child Care

The cost of Child Care in Maine can vary depending on several factors. Understanding these factors can help parents and caregivers make informed decisions about Child Care options.

Location

Location plays a crucial role in determining Child Care costs, and the cost of living and demand for Child Care services can significantly affect prices. In more urban and affluent areas, the cost of Child Care is typically higher than in rural regions.

Type of Care

In-home providers, such as family Child Care homes, may charge less than center-based care due to lower overhead costs. However, center-based care may offer more resources and structured programs for children.

Age of Child

Your child's age can also impact the cost of care in Maine. Infant care is typically more expensive than care for older children due to the need for more one-on-one attention and specialized care.

Maine Child Care Cost Per City

Portland Child Care

- As of January 2025, the average rate for Child Care providers in Portland is \$20.80 per hour.
- The weekly cost for Child Care providers working a 40-hour week is **\$832**, while the monthly cost is approximately **\$2,704** for 130 hours of work.
- For infant care, the hourly rate is \$21.15, or \$2,750 a month.

Lewiston Child Care

- As of January 2025, the average rate for Child Care providers in Lewiston is \$18.42 per hour.
- The weekly cost for Child Care providers working a 40-hour week is **\$737** while the monthly cost is approximately **\$2,395** for 130 hours of work.
- For infant care, the hourly rate is \$17.33, or \$2,253 for a month.

Bangor Child Care

- As of January 2025, the average rate for Child Care providers in Bangor is \$18.74 per hour.
- The weekly cost for Child Care providers working a 40-hour week is **\$750**, while the monthly cost is approximately **\$2,436** for 130 hours of work.
- For infant care, hourly rates are around \$16.83, or \$2,188 monthly.

Auburn Child Care

- As of January 2025, the average rate for Child Care providers in Auburn is \$19.09 per hour.
- The weekly cost for Child Care providers working a 40-hour week is **\$764**, while the monthly cost is approximately **\$2,482** for 130 hours of work.

Biddeford Child Care

- As of January 2025, the average rate for Child Care providers in Biddeford is \$20.14 per hour.
- The weekly cost for Child Care providers working a 40-hour week is **\$806**, while the monthly cost is approximately **\$2,618** for 130 hours of work.
- For infant care, these figures are closer to \$19.91 hourly and \$2,588 monthly.

Grants, Subsidies, and Financial Assistance for Subsidies in Maine

Here are three subsidies and grants available to parents in Maine to make Child Care more affordable:

1. Child Care Affordability Program (CCAP)

<u>CCAP</u> helps eligible families pay for Child Care so parents can work, go to school, or participate in job training programs.

Amount: Varies based on family income, size, and Child Care costs.

Requirements:

- Parents must be employed, in school, or in job training
- Family income must be within eligibility guidelines (up to 125% of state median income as of July 2024 – for a family of 4, this is \$130,898.75).

• Child must be under 13 years old (or under 19 if special needs)

2. Child Care Tax Credit

This is a state tax credit for child and dependent care expenses.

Amount: 25% of the federal Child Care credit, doubled for quality Child Care providers. Refundable up to \$500.

Requirements:

- · Must qualify for the federal child and dependent care tax credit
- Expenses must be for children under 13 or disabled dependents

3. Head Start and Early Head Start Programs

Federally-funded programs providing free or low-cost early education for eligible families.

Amount: Free or reduced-cost Child Care and early education services

Requirements:

- Family income at or below the federal poverty level
- Children must be under 5 years old
- Priority given to children with disabilities or in foster care

Cost of Child Care in Maine vs. Other States

Frequently Asked Questions

What is the Child Care subsidy limit in Maine?

The Child Care subsidy limit in Maine varies depending on the applicant's income and family size. For a family of size four, your household must be earning less than \$83,087.76 to be eligible.

What is the daycare ratio in Maine?

The <u>daycare ratio in Maine</u> is 1 teacher to every 4 children for infants and toddlers, and 1 teacher to every 12 children for ages above 5.

Are there any programs or initiatives in place to help families with the high cost of Child Care?

Yes, there are various programs and initiatives in place to help families with the high cost of Child Care, such as:

- **Child Care Subsidy**: Many states offer subsidies for low-income families to help cover the cost of Child Care.
- Head Start and Early Head Start: These are federally funded programs that provide free or low-cost early education and Child Care services for eligible families.
- **Tax Credits**: Families can claim tax credits such as the Child and Dependent Care Credit to offset some of the costs of Child Care.
- **Employer Benefits**: Some employers may offer options such as Flexible Spending Accounts or Dependent Care Assistance Programs to help employees cover Child Care expenses.

At the federal level, income tax credits are available to businesses that provide Child Care for their employees. The federal credit is typically 25% of Child Care expenses, plus 10% of resource and referral expenses, with the annual maximum of \$150,000.

While the federal credits are helpful, a majority of states are now offering tax credits or incentive programs for businesses to stimulate economic growth by providing Child Care solutions to their employees. What is the ROI of providing Child Care Benefits?
