A 2024 peer-reviewed study by The Trevor Project published in [Nature Human Behaviour](#), found that “anti-transgender state-level laws has a significant and causal impact on suicide risk among transgender and nonbinary young people across the United States.” Furthermore, the findings demonstrated “a significant increase in suicide attempts among all participants whose home state had enacted at least one anti-transgender law. The highest increase in suicide attempt rates – ranging from 7% to 72% — was reported among participants younger than age 18.”
