*This bill was written for the explicit purpose to suppress the self determination of identity, even more explicitly for transgender children.*

*Despite children who are not transgender having nicknames, with no uproar in the past, it is transgender students, who are supported as the human beings they are, with the right to self expression and self determination, that are being targeted with this bill.*

*I was once a student in Maine schools, and I admired and appreciated teachers who supported transgender classmates. I've had classmates who come out as trans, and changed their names and were embraced by teachers and staff. I saw how much happier they looked when they were being supported, compared to ones who weren't.*
