

Dear Sen. Carney, Rep. Kuhn, and Members of the Judiciary Committee,

My name is Brigitte West. I am a resident of Warren, writing to testify in strong **SUPPORT** of both LD 1971 and LD 1259; they would provide much-needed explicit and detailed policy to ensure state law officials' time and resources are directed **only** toward their intended local duties, **not** being deputized as federal immigration agents (with little to no training).

Unfortunately, these Bills are especially vital under the current federal administration. We have now repeatedly witnessed federal powers blatantly ignoring core values of the Constitution. According to the Fifth and Fourteenth Amendments, all United States residents-- whether they be citizens, non-citizens, immigrants, or undocumented individuals-- are entitled to Due Process. And yet, there are weekly reports of U.S. residents, with all types of citizenship and residency status, being rounded up and "disappeared" by federal agents. People like Mahmoud Khalil and Rumeysa Ozturk, arrested for political reasons in violation of their right to free speech and denied due process for weeks, or the 200 Venezuelan immigrants deported to El Salvador's max-security gang prison in defiance of a court order banning federal officials from doing so. These are only a few of the most-reported cases. There are thousands more that have not made headlines. We must not ignore these flagrant violations of the Constitution, or fail to name them as what they signal: Fascism. If history has taught us anything, we must ensure that every opportunity to resist authoritarian overstep is taken. Passing these Bills is one such opportunity to avoid complicity in unconstitutional actions, while legally protecting local and state law officials who refuse to cooperate with federal agencies from any possible Trump administration attempts at retribution.

Immigrants are vital to Maine's economy and increasing cultural diversity. Growing up in Portland in the '90s and '00s, I had friends and classmates whose families were refugees from Cambodia and Somalia, and my family sponsored a family who had fled the war in Bosnia.
