## **IN OPPOSITION TO LD 797**

"An Act to Amend the Laws Regarding Work Search Efforts for Unemployment Benefits and to Eliminate Benefits for Temporary Unemployment"

Before the Joint Standing Committee on Labor Hearing: March 19, 2025 at 10:00 a.m.

Dear Chair Tipping, Chair Roeder, and distinguished members of the Committee on Labor,

On behalf of more than 4,000 registered nurses and health care professionals providing patient care in our state, the Maine State Nurses Association/National Nurses Organizing Committee/National Nurses United (MSNA) urges the Committee to oppose LD 797, "An Act to Amend the Laws Regarding Work Search Efforts for Unemployment Benefits and to Eliminate Benefits for Temporary Unemployment."

Unemployment funds should go to pay unemployment benefits, not to process pointless paperwork. There is already a requirement that people receiving unemployment benefits seek work. LD 797's requirement to list three activities will not make anyone more effective at looking for work. It may cause people to lose their benefits because of the greater chance of denials for procedural reasons, however. The onerous demand that the Department of Labor audit 10% of work search efforts may also cause delays.

LD 797 would also make it harder for people to receive benefits while temporarily unemployed. Furloughed employees who expect to be able to return to their jobs should not be forced to engage in unnecessary job search activities or forgo needed unemployment benefits. Widespread economic uncertainty caused by the federal

government pulling grant funding temporarily or permanently,<sup>2</sup> firing and sometimes rehiring federal employees,<sup>3</sup> and destabilizing the market means a higher number of workers may be furloughed from jobs this year. They need support.

Maine DOL should not be saddled with extra procedural burden while it is busy helping workers who have lost their jobs.<sup>4</sup>

We urge the Committee to oppose LD 797.
