We are opposed to this bill as it is currently written because it could effectively put someone out of business for what could be an honest mistake, especially in these perilous economic times. Though we believe that all parts of the statute reflected in this bill are very important parts of Maine's labor laws, we do believe the penalties suggested by this bill could be excessive because of a miscalculation that could affect multiple employees, thereby potentially levying a knockout punch of \$2500 fines. If businesses could not afford to pay income tax on their PPP forgiven loans, they certainly cannot afford this.

Perhaps the fines should be increased as they have not been addressed since 1999, but increasing the subsequent violation fine from \$100 to \$500 to a range of \$500 to \$2500 for subsequent offenses is too much. Maybe keeping it between \$500 and \$1000 per violation for multiple violations would be a good first step. We also definitely feel that the double damages payment to the employee, though reduced from treble damages in the first version of this bill is excessive, as well. Add in attorney's fees for both the employer and employee and you can easily see why this could jeopardize a small business' survival, during and shortly after a pandemic. We have no comment on the extra inspectors.
