## SUMMARY

This resolve directs the University of Maine System to study and analyze the potential effects on the State's economy of the State adopting permanent Atlantic Standard Time and determine if that adoption will serve the convenience of commerce as required by the United States Department of Transportation. University of Maine System is required to fund the study through private donations and to submit a report with suggested legislation by December 31, 2021 to the Joint Standing Committee on Innovation, Development, Economic Advancement and Business, which may submit legislation to the Second Regular Session of the 130th Legislature.

# PRIOR SESSION

The SLG committee considered 2 bills in the 129<sup>th</sup> Session on daylight savings time.

- 1. 144, An Act To Opt Out of Federal Daylight-Saving Time and To Ask the United States Secretary of Transportation To Place the State in the Atlantic Time Zone; and
- 2. 885, An Act To Adopt Eastern Daylight Time Year-round

The committee's amendment (unanimous) became P.L. 2019, ch. 26.<sup>3</sup> The law changes Maine's standard time to eastern daylight time year-round if the following conditions are met:

- 1. Federal law permits the District of Columbia and all states within the eastern time zone to observe eastern daylight time year-round; and
- 2. The District of Columbia and all the eastern time zone states elect to change to year-round eastern daylight time

# INFORMATION / POTENTIAL ISSUES / TECHNICAL PROBLEMS

### OPTING OUT OF DST

Federal law allows a state to move into the Atlantic Time Zone and then opt out of DST by filing a petition for a change in time zone. The Secretary of Transportation evaluates the petition based on the change's impact on commerce. The required elements for the study in this bill mirror those required by the US DOT.<sup>4</sup>
