I strongly urge you to please vote “OUGHT TO PASS” on L.D. 805, “An Act To Allow Municipalities To Prohibit Firearms at Voting Places” OUGHT TO PASS.

As someone who cares deeply about voting access and security, personal safety, and local autonomy, I was unpleasantly surprised to learn that current Maine law does not allow Maine’s local municipalities to ban firearms from polling places on election day.

Voting is the most basic, essential and sacred right of every American, and it is imperative that we all do everything in our power to ensure the right of all citizens to confidently and safely exercise that right. Throughout this country, there have been numerous unfortunate instances in which certain persons have brought firearms to polling places, with the apparent intent of intimidating potential voters from voting. Being stared down by, or even in close proximity to, someone with a firearm who is not an officer of the law while one is waiting to vote would be extremely intimidating. Additionally, having persons who are not law enforcement officers carrying firearms at voting places is a dangerous, potentially deadly, accident waiting to happen.

As you are well aware, guns are strictly prohibited in the Maine State House and at legislative committee meetings and hearings, for obvious public safety and security reasons, and to ensure the calm and thoughtful deliberation of legislative issues, without fear of threat of violence.

L.D. 805 should be an absolute no-brainer to ensure safe, orderly and secure elections. It reasonably exempts firearms carried by law enforcement officers, as well as firearms which are safely and securely stored in locked vehicles. It does not compel municipalities to ban firearms from polling places on election day, but rather returns to municipalities, whose election officers are in charge of the safe and efficient implementation of elections, full autonomy over those elections.

Maine’s Constitution favors home rule by municipalities, yet as the law stands currently, the Legislature has prohibited counties, municipalities and political subdivisions of the State from regulating firearms, except for hunting within a municipality. (25 M.R.S.A. § 2011) This is unacceptable, as it robs communities and election officers responsible for safely and efficiently managing our elections from being able to manage those elections so as to encourage voting while ensuring public safety.

This bill will give back to local communities and election officers the autonomy they need to safely manage our elections. It will inspire confidence in voters and discourage voter intimidation. It will also avoid potential tragedies which could be caused by persons who are not law enforcement officers brandishing and possibly using firearms in polling places on election day. Let's not wait for such a tragedy to happen to react; let's be proactive, and give back to Maine's municipalities, who know how to safely and securely to best serve their local communities, the power to safely, securely and efficiently manage our elections.
