You talked to Erica earlier about Bouchards, literally after you got off the phone with her I got a call that Bouchards is on the highway doing a tractor trailer crash 5 miles form my shop. The crash is right in the middle of my shop and T&W garage, bouchards is 18 miles away. He has a retired state trooper on his payroll and a currently employed DOT supervisor on his payroll that both allegedly drive tow trucks for him, Yet ive never seen either in a truck. Ive seen the dot guy sweeping his floors on the weekends.... Theres something going on here and it is very unfair, I have millions invested here and this makes 9 strait, in a row, heavy truck crashes Bouchards has done on my side of town that neither myself or T&W has gotten.....

ON 12-27-2019 at 11:42 am my company received a phone call from Justin Sawyer, phone # 207-217-4950, asking if we could come to the interstate around mm 174 Carmel to pull his 2007 GMC truck from the median after sliding off, I gave Justin a 30 min ETA and immediately called the state police dispatch to inform them, that the customer had called us to that location to recover the truck and its location. I asked if any troopers would be available to provide lights, and I was told there was not any available and it will have to wait until they got caught up, I said them that was perfectly ok with us and we would just stop and pick up the customer so he was safe and proceed to the nearby rest area until they were ready for us. Upon arriving on scene to pick up the customer, a DOT truck stopped and provided some lights and very shortly after a state trooper showed up with another towing company behind him with a wrecker. The trooper approached my driver and told them he had already called another company, they were on the way and he needed to leave, my driver asked why this was OK and explained we were called by the owner, informed state police dispatch we were coming, and the owner wanted to bring the truck to our repair facility and have the damaged tires repaired so he could make his way home for the weekend, the trooper, unsure of name, licence plate #XXX told my guys he didnt care who was called he had a company on the way already and he needed to leave, he also approached the vehicle owner and told him he didn't care who he had called and that "We dont deal with Leonards" and the company he called was going to pull the truck out and tow it off. My driver radioed me to ask what I wanted him to do, and I asked him to please have to trooper call my personal cell phone to discuss the matter, his reply was "i will when i'm good and ready, now leave" I just told my driver to just leave and not cause a scene. I do not feel this is fair treatment, and this is not the first Instance, this is a repeated problem continuously almost on a daily basis, our everyday contracted clients are forced to use competing companies when involved in acsedenty becuase police or police dispatch is calling a wrecker to the scenes befor anyone even arives or anyone is asked for a preference in wrecker service, by the time a phone call is made to my company and we notify police dispatch we are continously told "weve already called another company" and are unable to service our customers. I belive there is a great deal of favoritism with one company in particular bouchard towing. The very same trooper from this incedent was seen later on sitting in the crossover with Bouchard towing and traveling up and down the highway with Bouchard towing, pulling out vehicles, there have been multiple tractor trailer truck crashes involving my customers that were forced to use bouchards because the trooper called them as soon as report of the crash came over the radio, and would not give them an option when they arrived. This is becoming very financially detrimental to our company and its 13 employees with family's to feed. I do not believe that it is fair for nearly 90% of the large truck crashes on the interstate are given to one company, when we have the clientele and have made the investment to do the job just as safe and efficient as any other company if not more. From MM157 where Troop E starts all the way up north, over 100 miles of interstate, this favoritism is shown, with 90% of the truck crashes going to one company Bouchard towing. There is no possible way for this one company to possibly keep up with the normal everyday towing needs of the area, with my company alone providing over 800 regular everyday towing services, our long list of clients need to be able to depend on us if they are involved in an accident, and is financially crucial to our survival. In nearly 3 years of towing large commercial trucks the state police have not called us for a crash on their own, ever, not once, any crash we have gotten was by request of the truck driver or owner.
