It has been difficult to compete with the low wages. Just in a one block area in the east end of Portland two of the biggest projects had zero companies form Maine. The Pre-cast parking job went to a NH based company, the structural iron went to a company out of Vermont and the foundation was done by a Massachusetts based company that was flying their construction workers up from Fall River. This on a project that is for a local brewery, the only local thing about the project is the General Contractor who subbed the job out to out of state companies who brought their out of state employees. One of these contractors did not register as a foreign entity with the Secretary of State or fill out the proper documentation to work in the State. I was on an organizing drive across the street talking to the structural ironworkers on that project, they were all from Virginia or North Carolina. Mainers and Maine companies are getting locked out of jobs in their home state by low paying out of state companies with poor safety records and pay so low that no company in this state can compete. This bill will help level that playing ground by requiring out of state companies to hire local as much as possible. This is important to help train the people of our state in the trades and to make our own self sufficient construction economy.

The contractors that Ironworkers Local 7 work with in Maine are either local or when they come from out of state they hire local. It is one of the great benefits to being a union signatory contractor. When you bid a job away from your base there is a readily available local workforce there to pull from. Your company can show up with a few key employees and then pull from the local labor force. This behavior is the type that should be encouraged and followed by any contractor, however in Maine we think somehow this to be different. Meanwhile out of state contractors build our new hospitals, colleges, judicial centers and brewery's using an out of state workforce and that is just in the Portland, Maine Area.
