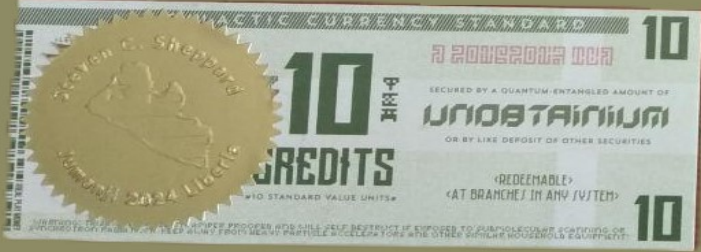
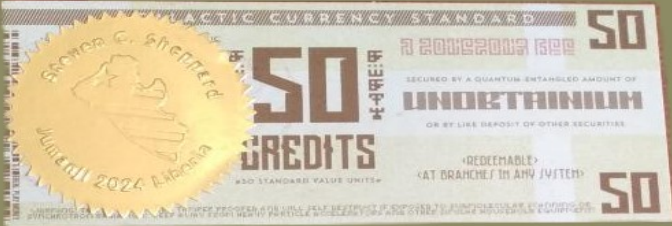

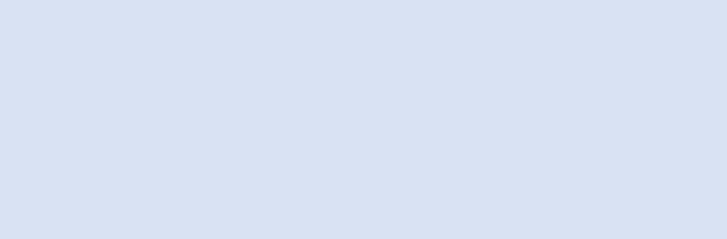

The attachment file is also a "word" document that explains how accountability can be so interesting for the genius auditor or the mentally ill authority or auditor. The auditors will need a well and fair stable account of good salary around \$300,000 dollars - half of which could be used to pay for state expenditures and be reimbursed or not.

The auditor will need protection, an attorney, perhaps militia and other expenditures that are to come.... All this is a possible and more orderly solution.
