When he taught his students about the Holocaust, he didn't treat it as a static, closed chapter of history. Instead, he taught the Shoah by drawing a direct line to current-day human rights abuses. He believed the only way to honor the phrase "Never Again" was to develop an active conscience regarding the suffering of others in the present.

In my faith we are guided by the commandment in Leviticus: "Do not stand idly by while your neighbor's blood is shed." When the State of Maine invests in or contracts with entities that benefit from genocide, apartheid, ethnic cleansing, or war crimes, we are doing exactly that, standing by while providing the financial machinery that allows blood to be shed.
