Dear Senator Diamond and Representative Martin:

The American Property and Casualty Insurance Association submits this testimony in opposition to LDs 284, 354, 388, 431, 490, 565, and 712 all of which in one fashion or another would weaken Maine's current inspection laws. Maine's inspection program results in safer cars and saves lives. This issue has been raised a number of times before this Committee. In the 129th legislature the bills were LDs 110, 117, 270 and 389. Similar bills have been proposed in numerous prior legislatures. The benefits of Maine's inspection laws include, among other things, lower insurance costs and safer motor vehicles. The value of inspection laws is confirmed by a study conducted by the Pennsylvania Department of Transportation in March of 2009.

The Executive Summary states:

*This report describes the activities and results for the Vehicle Safety Inspection Program (VSIP) Effectiveness Study...performed by Cambridge Systematics, Inc. (CS) on behalf of the Pennsylvania Department of Transportation (PennDOT). The research considered the effectiveness of vehicle safety inspections on the number of fatal crashes, and the cost-effectiveness of the program compared to the cost of inspections to the owners of Pennsylvania registered vehicles. **The results of the research clearly demonstrate that the Vehicle Safety Inspection program in Pennsylvania is effective and saves lives.***
