Re: LD 557 – An Act To Require Photographic Identification for the

Purpose of Voting

Position: NEITHER FOR NOR AGAINST

The Maine Town & City Clerks' Association is Neither For Nor Against LD 557 for several reasons and we thank you for the opportunity to outline out points for your Committee.

Members of the Maine Town & City Clerks' Association's Legislative Policy Committee were not opposed to the idea of requiring voters to show ID at the polls, and many were in favor of the concept. The implementation of requiring IDs at the polls could increase voter confidence in the process, decrease errors at check-in, result in less chance for voter fraud, would not be a hardship to voters since most already have ID, and could strengthen the voting process.

#### Some concerns that were raised:

- There are no procedures outlined regarding voters who do not have any of the specified identification documents to provide at the polls. Past legislative proposals have outlined a cumbersome provisional ballot procedure that created significant procedural challenges.
- Since absentee voters are not required to show identification in order to obtain their ballots, in-person voters would be held to a different standard by having to provide identification in order to obtain their ballots.
- This ID review could potentially slow down the voting process and may require towns to bear the costs of hiring more staff on election day.

- This requirement could create a barrier for some voters who are unable to meet this requirement.
- This bill states that college or school IDs issued in this state would not be considered acceptable forms of identification, which implies that the same documents that are issued outside of Maine would be acceptable.
- Members also questioned whether the identification documents would be used to verify a voter's address and what the process would be when that ID address does not match the voter registration address.
- Current state law allows a citizen to provide a utility bill to register to vote if they
  are unable to provide other identifying documents. This law would create a
  higher threshold to allow a registered voter to vote than is in place to register to
  vote.
