Summary

As shown in the table above, 27 states and the District of Columbia have enacted legislation to legalize sports betting. Of those states,

- 21 states (AR, CO, DE, IL, IN, IA, MI, MS, MT, NV, NH, NJ, NM, NY, NC, OR, PA, RI, TN, VA and WV) and the District of Columbia have operational sports betting programs, and in six states (AZ, LA, MD, SD, WA and WY) sports betting programs are legal, but not yet operational.
- In eight states (IL, NH, NJ, NY, RI, SD, VA and WA) and the District of Columbia, in-state collegiate sports are excluded from authorized sports wagers, one state, Oregon, excludes all collegiate sports and one state, Delaware, excludes all in-state professional and collegiate sports.
- In regard to online and mobile sports betting, 19 states (AZ, AR, CO, IL, IN, IA, MD, MI, MS, MT, NV, NH, NJ, NY, OR, PA, RI, WA and WV) allow online and/or mobile wagering, and seven of those states (IL, MD, NV, NY, TN, VA, WY) permit "untethered" operation of online or mobile sports wagering platforms that are not required to partner with or be affiliated with a land-based gaming facility.
