Dear Honorable Members of the 127th Legislature:

Under the authority vested in me by Article IV, Part Third, Section 2 of the Constitution of the State of Maine, I am hereby vetoing LD 1460, "Resolve, Regarding Legislative Review of Portions of Chapter 301: Fee Schedule and Administrative Procedures for Payment of Commission Assigned Counsel, a Major Substantive Rule of the Maine Commission on Indigent Legal Services."

This legislation approves of Maine Commission on Indigent Legal Services' rulemaking to increase the rate of pay for attorneys who provide indigent legal services. This pay raise and the entire system for providing indigent defense is a bad deal for Maine, and I cannot abide continuing to prop up a system that refuses to hold attorneys accountable or introduce cost predictability, it is unfair to Maine's indigent and Maine taxpayers.

The Commission and the current system for providing indigent legal services were established in 2009 in order to separate this function from the Judicial Branch. In that time, the budget for the Commission has grown year over year from a little over \$10.5 million in fiscal year 2011 to the budgeted amount of more than \$19 million for the current fiscal year. Not only has the budget for these services exploded, but also there seems to be no way to predict this growth. As the Legislature well knows, it is asked almost every fiscal year to provide additional, unbudgeted supplemental funding to this Commission because nobody seems to be able to manage (or predict) this spending. In fact, I understand that the Commission is now seeking over \$3 million in unbudgeted supplemental funding for the second year of biennium.

It appears the fiscal appetite of this Commission will never be satiated and the pay raise provided for by this resolve only exacerbates this problem.

I have proposed the creation of a public defender system to regularize the costs of providing this service and to improve the quality of services we provide to indigent defendants. Unfortunately, when those who stood to lose – the lawyers now billing the State – showed up in force to keep taxpayer dollars flowing in their direction, legislators wilted and opted for the *status quo*. I will not enable this system, let alone add to the problem by giving those involved a pay raise. For these reasons, I return LD 1460 unsigned and vetoed. I strongly urge the Legislature to sustain it.

### JOINT RESOLUTION RECOGNIZING MARCH AS COLORECTAL CANCER AWARENESS MONTH

WHEREAS, colorectal cancer is the third most commonly diagnosed cancer and the second most common cause of cancer deaths for men and women combined in the United States and it affects men and women equally; and

**WHEREAS**, every 3 minutes someone is diagnosed with colorectal cancer and every 10 minutes someone dies from colorectal cancer; and

WHEREAS, the vast majority of colorectal cancer deaths could have been prevented through proper screening and early detection but only 39% of colorectal cancer patients are diagnosed at an early stage; and

**WHEREAS**, the survival rate of individuals who have early-stage colorectal cancer is 90% but the survival rate is only 10% for individuals diagnosed after the cancer has spread to other organs; and

**WHEREAS**, the national goal established by the National Colorectal Cancer Roundtable is that 80% of Americans 50 years of age and older be screened by 2018; and

**WHEREAS,** if the majority of people in the United States 50 years of age or older were screened regularly for colorectal cancer, the death rate from this disease could plummet by up to 70%; and

**WHEREAS**, colorectal cancer is preventable, treatable and survivable in most cases; and

**WHEREAS**, observing a Colorectal Cancer Awareness Month would provide a special opportunity to offer education on the importance of early detection and screening; now, therefore, be it

**RESOLVED:** That We, the Members of the One Hundred and Twenty-seventh Legislature now assembled in the Second Regular Session, on behalf of the people we represent, take this opportunity to recognize March as Colorectal Cancer Awareness Month.

**THE PRESIDENT**: The Chair recognizes the Senator from Piscataguis, Senator Davis.

Senator **DAVIS**: Thank you very much, Mr. President. I'd just like to take two or three minutes or so to speak to this. According to the website called ScreenMaine.org, 300 people in the State of Maine are going to die of colon cancer this coming year. According to this website, which tracks several different types of cancer, 90% of these people would not die if they had early screening. These people will be young and old. They'll be Republicans, Democrats, unenrolled. They will be all sorts of folks and they'll all die because they didn't have early screening.

I'd like to tell you about a couple of folks that I'm very familiar with; one really familiar with. The first one I'd like to tell you about is my good friend Chandler Woodcock. He is the Commissioner of Inland Fisheries and Wildlife, and we all know that. His brother, Steve, had colon cancer. He was 54 years old. On his deathbed he insisted that his brother Chandler have a colonoscopy. Chandler said, "Nah, I'm not going to do that," but he did. Guess what? They found cancer and he was operated on and got it early and his life was saved. His brother wasn't so fortunate. He died. I learned this morning that my good seatmate, the good Senator from Franklin County, Senator Saviello, at age 42 had colon cancer and he told me that he wasn't feeling well and he went to the doctor and a long series of events occurred and they found two very cancerous polyps in his colon and he's here today because of early screening.

Mr. President, in the summer of 2011 my wife had a colonoscopy; and Dr. Evans in Dover-Foxcroft told her, "Don't wait the five years they usually say. Don't do that. You have one within the next three years," and she did. Lo and behold, she had colon cancer. First there was surgery and then sixteen treatments of chemotherapy, but in April of last year she was found to be in remission. Since that time we talked about it, Patti and I did, and we decided that we would go public with this. I put articles in the newspapers back home. I did everything that I could do to make the public aware. Folks, I can't tell you how many people have come up to me and thanked me for that. I've had total strangers come up to me and say, "I read your article. I went and had a colonoscopy and they found some polyps that were cancerous." You all have the opportunity to do this. You help your constituents if you do this.

Finally, go to ScreenMaine.org. It gives you a lot of information about different types of cancer. Thank you, Mr. President.

Senator **GRATWICK**: Thank you very much, Mr. President. Just very briefly. I'd like to thank very much the comments by Senator Davis. I think they're highly appropriate. This is something that should particularly appeal to this group here, over age 50. We're all going to die someday. Colon cancer is a way you do not want to die. No one likes having colonoscopies. If you need to, you can have anesthesia. I think it's something that's now become widespread. This whole issue is supported by the Maine Hospital Association, by the Maine Medical Association, by insurance companies. It's a way to save not only money but save health. I commend you very much for bringing this up, sir. Thank you.
