Off Record Remarks

**THE PRESIDENT**: The Senate is indeed honored today to have with us a very special person, a good friend to us all, and the wife of our dear friend, the late Senator Joel Abromson. The Honorable Linda Abromson is here with us today. Under unanimous consent, I would ask that the Sergeant-At-Arms escort the Honorable Linda Abromson to the Rostrum where she may, on the record, address the Senate.

**LINDA ABROMSON:** I will take that standing ovation for Joel. Thank you. What an incredible place this is to speak from. Mr. President, Members of the Senate; Joel had, on a couple of occasions, the opportunity to come to this Rostrum and he talked about how impressive it was and what a distinguished audience it was, and in my case today, what a special topic it is, my beloved Joel. Thank you, thank you all. I'm hoping that, for me at least, and maybe for you, today will amount to a kind of closure. The Senate has been such an important part of our lives for such a very long time.

I'd like to tell you a couple of stories - Joel's favorite campaign story and my favorite constituent story. But before I do that, I meant to do something else and I forgot. There are two very special people sitting in the back of the room. My brother, Rob Elowitch, who came up with me and one of Joel's very best friends, Jerome Goldberg, who is sitting with Rob. Several of you may have met Jerry. He was one of the people who pretty regularly chauffeured Joel up here and back when I couldn't.

Two stories: In 1994, Joel's first campaign, Stan Bennett offered Joel the use of one of his boats for a day. So Joel and Tim McManus, his campaign manager, and Stan got into the boat one day before the primary. The primary was in June. Now Joel didn't have a primary opponent, but he also didn't have any name recognition except mine, which I reminded him of often. It seemed appropriate to get out there and get his signs, his name, and his face in front of the electorate, even if he didn't have a primary opponent. So a couple of weeks before the primary in June, they took the boat and they went out to Peaks Island. They met some supporters, and they had coffee in the little coffee shop just after you get off the ferry. They distributed some literature, they dropped off some signs, and then they proceeded onto Long Island where they did the same thing all over again - prearranged with some constituents to do these various tasks with and for Joel. Then they made their way to Cliff Island. At Cliff they did not have any pre-identified supporters. They were hoping to find somebody. They got off the boat, they took a sign, and they started to walk. They found a fellow, an islander, and Tim McManus went over to him and introduced Joel as a candidate for the State Senate and asked the fellow if he would be interested in supporting Joel's candidacy. Well, he had a few questions to ask about taxes and whatever. Apparently Joel gave some morethan-adequate answers and the fellow said, 'Okay, I'll support

you.' Tim said, 'Well, we've got just one task we'd like you to do. We have this sign. We'd like you to put it up now. The day after the primary election in a couple of weeks, we'd like you to take it down, put it in your cellar, take it back out again in the middle of October, put it up again in the middle of October, and take it down the day after the election in November. Would you be willing to do that?' The fellow looked at Joel and said, 'Ayuh, but how did you know I had a cellar?' Joel loved telling that story.

Last November, when Joel's illness became very well known, not that he kept it a secret, but it was becoming more well known and his constituents were becoming aware, he received a letter from a woman whose name is Merryl Hodgson. I don't know her. Joel had met her campaigning a couple of times. I called her and asked her if I could use her letter and the essay she sent with it and her name. She gave me permission to do so. 'Dear Joel, Remember that letter we asked you to send to our son, Nate, about six years ago requesting some words of wisdom? Nate used your story in his application to Bowdoin. One never knows how far an act of kindness will spread out and how many people will be affected. Your many actions as a politician will reverberate for years. We appreciate all you have done. Thank you. Love, Merryl Hodgson.' What was special about this letter was the essay application to Bowdoin that she enclosed. Joel received many, obviously loving, and supportive cards during his illness and since. This essay, the first half of it, reads, 'Several months' before my 13<sup>th</sup> birthday, my parents sent out a letter to my family and friends, my favorite authors, and a few politicians asking them to send words of wisdom to me for my birthday. My parents wanted to mark a right of passage into early adulthood for me. They provided a brief biography and one of the things they mentioned was how much harder I had to work in school to get the same grades my older brother received without much effort. On my birthday. I received a big scrapbook containing the results. One of my favorite letters was from Maine Senator Joel Abromson. He wrote about a man who found a caterpillar on a milkweed plant. He transferred the caterpillar to a jar and soon it formed a green chrysalis. Eventually he noticed the chrysalis moving a bit and knew it was ready to hatch. He watched as the butterfly struggled to open the chrysalis. He decided to help the process along by carefully cutting open the casing. A damp butterfly with folded wings emerged but it didn't open its wings and fly away as he expected. Finally he called a friend and described the situation. That butterfly will never fly, the friend explained. Butterflies struggle to get out of their cocoons to strengthen their wings. Without strong wings, they can't fly. This story has great meaning for me and has also brought me comfort.' By the way, I did ask Merryl if Nate got into Bowdoin, but this is this year's application and I won't have an answer until April. He had just written the essay. I will let you all know, when the time comes, whether he got in and decided to go.

My point in bringing it today was because I think it's Joel. Too many of us politicians get too many letters that we think are important and we haven't got time, right then, to write a response or do what it is that we've been asked to do. We put it to one side and eventually we get back to it. When we get back to it, eventually, the deadline has passed and we're somewhat relieved because now the responsibility of doing anything has gone or we've passed it over to somebody else or we've handled it in a quick way because we just didn't have time to deal with all the constituent issues. As I think you know, that wasn't Joel's style. Joel's style was to write a thoughtful, immediate response, no matter how many letters he got, no matter how many requests he got. This is the way he responded. There is another wonderful constituent story about a letter Joel wrote when a baby was born. But I don't tell it as well as Rick [President Bennett] does and many of you heard it at the testimonial for Joel. If you haven't heard it, ask Rick for that story. He does do a much better job than I do.

The most important thing, I think, that I wanted to do today was to extend some thank-yous. The first thank you is simply to all of you. You have been very important to both of us for a long time. You touched our lives in some very real, important, loving ways. I thank you all for that. Your letters, your visits, your phone calls, your cards, your flowers, so many of you having come to the testimonial. You made us both feel awfully good, Joel in particular. I know it's risky to single out people, but I'm not in politics any more - I can do it. A couple of former members of the Senate, Jane Amero and Phil Harriman, who, because they had more time than you do, spent a lot of time with Joel. They took him out to lunch. They took him for rides. Phil took him out to Two Lights one day. Jane made us the best apple pie I've ever had. The two of them were simply wonderful. I need to mention Joy, who's not here - [Assistant Secretary of the Senate] Joy O'Brien, who has gone to the Baldacci funeral. Joy was the first person to make an accommodation for us. A very thoughtful one. She gave us her parking space. As most of you probably know, at the time she had the best parking space in the parking lot. In addition to Joel having a handicap placard, which she got for us because at that point we hadn't yet thought of it, she also gave us her parking space. She used to go park somewhere else, saying she got here early enough to do that, and we should park in her space. That kind of thoughtfulness, obviously, continued. But that was the beginning. [Secretary of the Senate] Pam Cahill who has made herself and her office so totally available to me during the last difficult, confusing days when I didn't know what I was doing. Pam did, and she was there for me. I also need to mention [Senator] Peggy Pendleton and [Senator] Anne Rand. I'm not sure if either one of them are here. They've gone to the funeral, as well. I need to thank them. Both of them, as you probably know, are medical professionals. Both had called, both had offered their services, both wanted to do whatever they could do for me and for Joel whenever we wanted or needed them. Anne, as a matter of fact, was supposed to spend the day of the 14<sup>th</sup> of January with Joel, nursing him and tending to his needs, because I had hoped to come up to go to the Maine Human Rights Commission meeting. Joel never made it to the afternoon of the 14<sup>th</sup>. But that doesn't lessen the fact that Peggy and Anne were both so willing to share their expertise and their love with us. [Senator] Mary Small and [Senator] Karl Turner who made visits to us and calls to us and spent time with Joel, making sure that anything he wanted to know about what was happening here he was comfortable with and included in. I guess, Rick, the final thank you has to go to you. Rick never forgot us. He called, he came. The flag that flew over the State House I proudly have and the Proclamation I proudly have. The love and the comfort that Rick brought to us from all of you, from himself and his family. Sometimes you wonder if those things really do help, and they really do.

All of you, especially the few I have mentioned, and of most significance, of course, and you all know this already, [Senator] Jill Goldthwait. But maybe you don't know the whole story. If you do, you're going to hear it again. If you don't, it's important that you hear it. I was desperately looking for a nurse. Joel wanted so badly to come home from the hospital. The only thing he wanted at that point was to come home. I couldn't bring him. We couldn't get the nurses in place. We thought we had it for the following Monday, Tuesday at the latest, and Joel just didn't want that. I don't know who got in touch with Jill, perhaps Rick, but that Saturday around 5 o'clock on January 5<sup>th</sup>, I think, I got a call that Jill would be at the hospital and to have an ambulance ready and Jill would take us home. She did, and she took care of Joel. She taught me how to take care of Joel. She stayed until the nursing shifts were in place and ready to come on Monday. Only after she left, did I find out that January 5<sup>th</sup> had been her birthday. Jill, when I leave the rostrum, these flowers are for you. Happy birthday, belatedly, from Joel and from me. She let us take him home. She trained me. We were able to keep him home for as long as he was aware of his surroundings.

There is no question in my mind that you all are better because Joel was one of you. There is also no question in my mind that Joel was better because he was one of you. Thank you very much.
