Senator **DAUGHTRY:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I wanted to rise and speak about the late Bob Tardy, who was certainly one of a kind. When I first got

into the Legislature I was 25 and definitely a little bit wet behind the ears and I had big dreams and big legislative ideas and I immediately ran to put in a bill about chicken slaughter. I know a really glamorous, really exciting topic for most people to talk about on their first day in the Legislature. As I was navigating this brand new world, a very kind man came and talked to me and was very excited to, also, talk about chicken slaughter and egg laying and, honestly, all things chicken and that's how I met the Honorable Bob Tardy and I have to say that one thing I always appreciated is he could tell when someone was having a bad day and would come and just literally joke about things related to all things chicken, all things farming and he was someone I could ask for advice and count on and he's someone who will be greatly missed. I just wanted to pass on my condolences to his family and can't really imagine the halls without him. Thank you.

Senator **BLACK:** Thank you, Mr. President. Men and women of the House, I met Bob Tardy in 2011 as a freshman Representative and he became a great friend and a mentor to me. We shared the love of agriculture and we talked many times about bills and concerns in agriculture, but I will say that he didn't make many brownie points with my wife. The first year we were here he had a couple of hogs that he had picked up in Pennsylvania and, while my wife was at work one day, he brought them up to the farm and left them. But she got over it and she really enjoyed Bob and his wit and his many visits to the farm and the sugar house and though she did never forget the day that she found those hogs in the barn. I will miss the many calls and emails I received from Bob over the years on many, many bills and not just agricultural bills but many bills of concern to him and to our constituents. Agriculture has lost a champion. Definitely has lost a champion, a man that loved agriculture and rural Maine. I've learned a lot from Bob and I will not forget him.

**THE PRESIDENT:** The Chair recognizes the Senator from Kennebec, Senator Cyrway.

Senator **CYRWAY:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I just wanted to stand up a little bit about Bob Tardy and I first came on here he came up to me and said 'Boy, I remember your father.' He said, 'He'd take a corn planter and it was probably 20 or 30 years old, all rusty and everything, and he'd bring it back like brand new.' He said, 'I was just so impressed with your father.' Just out of the blue moon, you know, I mean in agriculture he was Mr. Agriculture, I think anyway. He just loved to work on agricultural bills and whatever and, anyway, one day, just out of the blue moon, he brings a sheet to me and he says, 'What goes on this sheet?' and it was my father's signature speaking here at the Legislature about pesticides and he says, 'I remember him coming up and signing that and giving the speech and stuff.' He said, 'I want you to have this.' He just would do certain things that you just never expected. So, I just thought he was a great guy. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Androscoggin, Senator Timberlake.

Senator **TIMBERLAKE:** Thank you, Mr. President. Ladies and gentlemen of the Senate, this is hard. Bob and I met back in

2010 when I first got elected. He wanted me to put a bill in to appeal the spray bill and Bob has a passion for agriculture that equals mine and Rusty's and a few others in here. But the thing I remember most about Bob was when you walked around the corner and he was sitting by the fireplace in his chair with his arms crossed, in that big, excuse me, Mr. President, but that big shit eating grin on his face and you knew he was up to something and usually it was to get me in trouble, to get me to come in and say something to the Senate President or the Speaker of the House. But it was always in good nature. And sitting on my desk is two apples. One of the stories he loved to tell about is the day he came to the farm and he walked up to the counter and he put two apples on the counter and the cashier says, 'That'll be \$5.' Well, I want you guys to all picture Bob Tardy for 30 seconds. The words that came out of his mouth were beyond belief and he talked about forever of paying \$5 for two apples and he could tell that story. These are my token back for the smile and enjoyment that I got in my life out of Bob. But that one thing that Bob taught us more than anything else was how to get along and he worked at no matter what he does to try to find consensus and figure a way to get through every farm bill there was and it's going to be something that I miss. I'm going to miss his random telephone calls out of the blue, out of the middle of the night sometimes, or his emails and he always ended his email with the Senior Tardy or the Elder Tardy. Well, Elder Tardy, rest in peace, my friend, and I'll miss you.

**THE PRESIDENT:** Well said. The Chair would also just like to quickly, many of you probably wouldn't know but when I first got elected and sat in the House, I had the good fortune of having Representative Josh Tardy sit directly behind me and that's probably how I first met Bob Tardy and I used to kid with him a lot that, you know, what happened to Josh. But, as everything has been said, I mean, Bob was very passionate about his family, agriculture, about the state of Maine. One of the things that, you know, over the years he had relatives that lived in the St. John Valley and he talked a lot about wanting to come. I think he did at times wanted to understand that more and I wish we would have had that time to, you know, research the way that he wanted to but, again, for the family, Marilyn and all the family, I'm really, really sorry for the loss because he was really a nice man to be around, fun to be around, and, you know, the institution has lost a really great person that thought extremely highly of the Legislature. With that, I'd like to pass this Joint Resolution for Bob Tardy.

Senator **MIRAMANT**: Thank you, Mr. President. Again, I'd like to acknowledge the good work of the Commission for coming up with the redistricting that they have and for what I understand was, other than some tense moments, very well done and with consideration of fair voting districts. One of the goals I heard from the very beginning was to try not to divide towns as much as possible and the Town of Owls Head, after having been whole for 10 years, is now being considered for division by 10% of their residents. It seemed that that was unnecessary and cumbersome, inconvenient and confusing for the folks in town and they requested that something be done, in particular that their voice be heard but it seemed to be after the opportunity for it. That's the way it goes. Sometimes at the end the information gets out and then the window is closed for comment. So, we tried to pass that on to the folks on the Apportionment Commission but they're looking at a margin of about 5% in either direction for what they can do for population. I also looked to see that this was not any kind of jerrymandering for advantage by any party. It was just simply trying to fill numbers to make it fit the formula. So, while understanding that, also knowing that it would be better for Owls Head if their town was whole and it be just a little outside the margin, you'll hear, maybe or maybe you won't hear, but anyways, it opens the door for someone to complain about it and sue over it. That would be the case if it was something where you're trying to gain advantage and one group felt like they were advantaged or disadvantaged. That's not the case here. It's just a little population thing that keeps the town whole. The other part of this is the House District that has traditionally had Vinalhaven and North Haven Islands, which are just divided by a narrow strip of water and everybody goes back and forth constantly for work, social, and everything else, and they work together so well that they feel like they're one community, and this just sent a rift down the middle and to have them both talking to me and their Representatives and just saying this just doesn't seem right. They seemed to take it harder than the town that was losing 10%. Again, it's a small number on North Haven so this amendment just has North Haven stay with Vinalhaven and keeps its residents whole. To have islanders just working together like this is always a great thing. They do join together against an outside cause now and then and they're doing it strongly. So, for those reasons, this amendment makes sense and I don't see any challenges coming because of it and I would appreciate your support. Thank you.

WHEREAS, Deputy Luke Gross served with the sheriff's office in Hancock County for 18 years and previously served in the police departments of Winthrop and Sabattus; and

WHEREAS, Deputy Gross was profoundly committed to law enforcement, believing in his job and in service, caring deeply for the people whom he served and contributing to his community both through his work and through participating in local charitable events; and

WHEREAS, in addition to his devotion to his professional duties, Deputy Gross had a passion for helping young people, serving as a camp leader at Camp POSTCARD and on the Hancock County School Board, working in local schools as part of the D.A.R.E. program and helping with the Deer Isle-Stonington High School Every 15 Minutes program, which educates students about the dangers of intoxicated and distracted driving; and

WHEREAS, Deputy Gross was struck and killed by a motor vehicle while responding to a call in the early hours of September 23, 2021; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Thirtieth Legislature now assembled in the Second Special Session, on behalf of the people we represent, express regret over the line-of-duty death of Deputy Luke Gross and our admiration for his honorable work in law enforcement and the community, and we send our condolences to his family.

Mr. President, ladies and gentlemen of the Senate, last Friday morning, September 23<sup>rd</sup>, our community was shaken by the news of the death of Hancock County Sheriff's Deputy Luke Gross. As you just heard, Deputy Gross died while in service in the early morning hours as he was performing his duties, assisting a vehicle that went off the road. It was news that devastated our community and our state. On that day we lost a dedicated law enforcement officer and active community member and a devoted husband and father. Luke Gross was a Hancock County native, growing up in Bucksport. Football player. Had a lifelong goal of becoming a law enforcement officer and for the last 18 years we in Hancock County have been extremely fortunate to have Deputy Gross serve within the ranks of the Hancock County Sheriff's Office, honorably serving and protecting the very communities he grew up in. Luke's passion was in helping kids and he had a remarkable connection with young people in our community. As his friends would say, Luke was like a big kid himself, with a fun and engaging personality and, whether it was through the various charitable events, working with our schools, volunteer work with Camp Postcard, or working in the DARE program, Luke prioritized engaging with young people, ensuring they knew they were valued and were always safe within our community. We send our heartfelt condolences to the many friends of Luke, to his fellow officers, and especially his wife, Lauren, and their two children,

and will remain ever grateful to Deputy Gross for his selfless service and devotion to keeping us all safe. Thank you, Mr. President.

Senator **CYRWAY:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I had a very good relationship with Deputy Luke Gross for many years. Worked with him in Winthrop when I was Kennebec County Sheriff and we did a lot of cases together and also in the DARE program. Him and I worked together at Camp Postcard and when he was at Camp Postcard - Camp Postcard stood for Police Officers Starting to Create and Reinforce Dreams and so what we would do is we'd work with the schools and for those kids that wouldn't have the privilege of getting to camp. The teachers would pick who they thought would benefit the most with the DARE program and they would go and we'd be camp counselors, volunteer for a week at different camps. In fact, years ago we used to do it at the State YMCA Camp and now it's being done in Casco at the camp out there. We used to be camp counselors and I worked with him and we have something kids that would get homesick or maybe they might act up because they didn't have the guidance of their families or whatever and Luke would take the time and really spend with them and get them back on track and just had a good way about him. Had a big heart. You know, when I hear people saying to take the DARE program away, this is a good reason why it shouldn't. Deputy Luke Gross was top notch. I spoke to him and asked him if he would be interested in the DARE program in his position when I gave it up and he was really interested in doing it. A great guy and I know that every time you'd ask him to do something he'd get it done. So, it is a great honor. Thank you.
