JOINT RESOLUTION RECOGNIZING MAY 2023 AS MENTAL HEALTH AWARENESS MONTH

WHEREAS, the mental health and well-being of all children, youth, adults and families in the State are of fundamental importance to the Legislature; and

WHEREAS, since 1999, the national suicide rate has increased more than 30%, with more than 10 million individuals experiencing suicidal thoughts and 1.4 million individuals attempting suicide annually in the United States; and

WHEREAS, approximately 129 individuals die by suicide in the United States each day; and

WHEREAS, suicide, opioid misuse and addiction and children's mental health issues are areas of concern in the State; and

WHEREAS, there are approximately 65,000 adults in the State who are living with a serious mental illness, including, but not limited to, bipolar disorder, severe depression and schizophrenia, and 27.2% of the children in the State have a mental illness, the highest rate of any state in the nation; and

WHEREAS, the effective treatment of mental health conditions is critical to reducing the number of individuals and families who find themselves in mental health crises, to breaking individual and generational cycles of mental illness and to promoting healing; and

WHEREAS, recovery from a mental illness requires access to professional services and involves families and caregivers as allies in recovery and as critical members of the care delivery team: and

WHEREAS, maintaining an open dialogue regarding mental health conditions encourages individuals struggling with mental illness to seek help and is an essential component to fighting the stigma associated with mental illness; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Thirty-first Legislature now assembled in the First Special Session, on behalf of the people we represent, take this opportunity to recognize May 2023 as Mental Health Awareness Month in order to raise awareness of mental health conditions and services and to break the stigma surrounding mental illness in the State.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Brenner.

Senator BRENNER: Thank you, Mr. President. Good morning. I rise today to recognize May as Mental Health Awareness Month. While 65% of Americans are concerned about the stigma around mental illness, only half of Americans say they are familiar with the mental health care system. Mental health is an incredibly important part of overall health. Not only is our individual and collective mental health critically important, mental health issues impact just about every one of us. One in five U.S. adults experience mental illness each year and less than half of them receive treatment. One in twenty U.S. adults experience serious mental illness each year and less than two-thirds receive treatment and we've seen a 31% increase in mental health related emergency department visits among adolescents alone. Mental health issues among children are also a growing concern. According to the National Institute of Mental Health, one in six children between the ages of 6 and 17 experience a mental health disorder each year. These issues can impact a child's development, academic performance, and overall wellbeing. Suicide is the second leading cause of death among individuals age 10 to 24 and untreated mental health issues can contribute to this statistic. By providing mental health services to children and their families, we can identify and address mental health issues early, preventing them from becoming more severe. Again, this year's theme, Mr. President, More Than Enough, underscores that all people, no matter where they are on their mental health journey, are deserving of support, resources, fulfillment, and a community that cares. Learning the early warning signs of emotional distress and suicide are important. Engage affected ones, loved ones, in supportive dialogue, fight the prejudice and negative attitudes that discourage those in need from seeking mental health support, and support funding and parity for mental health care and treatment because we are all more than enough. Thank you, Mr. President.

JOINT RESOLUTION RECOGNIZING MAY 2023 AS MAINE TREATMENT AND RECOVERY COURT MONTH

WHEREAS, Treatment and recovery courts nationwide are the cornerstone of justice reform and are recognized as the most successful justice system intervention in our nation's history; and WHEREAS, Maine treatment and recovery courts have been restoring lives and families and increasing public health and safety for more than 2 decades; and

WHEREAS, Maine now has 14 treatment and recovery courts, including 8 drug treatment and recovery courts, formerly known as adult drug treatment courts, 2 veterans treatment courts, 3 family recovery courts and one co-occurring disorder court; and WHEREAS, Maine treatment and recovery courts have served more than 2,000 individuals, indirectly benefiting tens of thousands of Maine families, employers and communities; and WHEREAS, treatment and recovery courts have substantially lowered the conviction recidivism rate of graduates to 6% compared to 41% of people with comparable characteristics and criminal records who did not attend a treatment and recovery court; and

WHEREAS, Maine treatment and recovery courts significantly improve substance use disorder treatment outcomes and substantially reduce addiction and related crime and do so at less expense than any other criminal justice strategy in Maine's history; and

WHEREAS, Maine treatment and recovery courts save an average of \$16,232 for every individual served while in the treatment court, significantly more than the national average of \$6,000 per individual; and

WHEREAS, Maine treatment and recovery courts improve education, employment, housing and financial stability, promote family reunification, reduce foster care placements and increase the rate of mothers delivering babies who are fully drug free; and WHEREAS, Maine treatment and recovery courts facilitate community-wide partnerships, bridging public safety and public health: and

WHEREAS, the success of treatment and recovery courts is the result of dedicated collaborative efforts and partnership of the following: the Judicial Branch, Maine Pretrial Services, Inc., the Attorney General and District Attorneys, the Maine Commission on Indigent Legal Services, the Department of Corrections, various county sheriff's offices, the Department of Health and Human Services, the Governor's Director of Opioid Response, Maine Behavioral Healthcare, Aroostook Mental Health Services, Inc., Wellspring, Inc., Recovery Connections of Maine, the Community Caring Collaborative and the Co-Occurring Collaborative Serving Maine, as well as a multitude of recovery and sober living homes, independent treatment providers and physicians and recovery support organizations; now, therefore, be if

RESOLVED: That We, the Members of the One Hundred and Thirty-first Legislature now assembled in the First Special Session, on behalf of the people we represent, take this opportunity to designate May 2023 as Maine Treatment and Recovery Court Month in recognition of the efforts of all professionals and participants who make our treatment and recovery courts work, and of the significant contribution our treatment and recovery courts have made and continue to make in the fight against substance use disorder, in helping our citizens in their recovery and in restoring hope.

I just want to add to the great information in this Joint Resolution some additional information. So, the Judiciary, as you know, conducts confirmation hearings when judges are appointed or reappointed to the bench and we hear, consistently, every time we do these confirmation hearings that involved judges who have presided over treatment and recovery court, that these judges consider this work among the most important and, honestly, the most rewarding work that they do on the bench, and I just ask that you keep this in mind when constituents reach out to you and ask what is Maine doing to help address substance use disorder. Think of the information in this Joint Resolve as a resource that you can use to point your constituents to and please continue to support this important work that's being done by the Judicial Branch. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Androscoggin, Senator Brakey.

Senator BRAKEY: Thank you, Mr. President. I rise opposed to the motion to accept the Minority Ought Not to Pass Report in non-concurrence. I will say I have - I've really appreciated the bipartisan spirit that has existed on the Health Coverage. Insurance, and Financial Services Committee, led by our colleague, Senator Bailey, who does a tremendous job as the chairman of that committee. In this regard, we are on opposite sides of this issue, but I do appreciate that there was strong - a strong bipartisan report among members of the House and Senate to pass this legislation. Because I think ultimately this is a small piece of legislation which would effectively for pharmacists who are - who prescribe opioids, under current law, which I will touch on the history of that in a moment, under current law. they're required to do three years of continuing education - I'm sorry, three hours of continuing education every two years. This would simply lower that from three hours to one hour every two years and for the history on this, this statute was put in place in a much larger package that actually came through the Health and Human Services Committee several years back when I was serving as the Senate Chairman. That package sought to do much bigger things than just address continuing education requirements. It was looking at the opioid epidemic through a much bigger lens, looking at imposing requirements on tapering people off, and I don't need to get into all the history of that. But sufficed to say, when this came through the Health and Human Services Committee, this was one of the smallest pieces of that entire package. We probably spent the least amount of time exploring this particular piece than everything else in that bill. What we've heard from the medical community is that this requirement of three hours every two years versus one hour every two years has just become a make work kind of thing. It takes time, it takes - it creates bureaucracy, and it hasn't actually been helpful in addressing the opioid epidemic, at least not helpful at this point in time. Perhaps years ago, when there was still a need for creating strong awareness about the dangers of overprescribing, perhaps three hours was appropriate then, but at this point one hour is sufficient and that's why a strong majority of

the committee from both parties supported the bill. I'll leave it there. I do think that we all care about the opioid epidemic. We should also make sure, though, that the policies we have in place are actually helping to combat the opioid epidemic, not just creating work to make us feel like we're doing something. Thank you, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from York, Senator Bailey.

Senator BAILEY: Thank you, Mr. President. I would first start out by saying I agree with the portion of my good colleague's statement saying that on our committee we do do a lot of bipartisan work, and that is also in part to the good Senator from Androscoggin County. We do disagree on this issue. I would first respond to the good Senator's comments by saying, and I think he just misspoke, but just to be clear, this isn't about pharmacists, this is about physicians and doctors and prescribing, and I would say that the three hours that they have to do every two years is part of their other CMEs, their continuing medical education, so it's not burdensome, it's not onerous. And I would say, as we're in the middle still of an opioid overdose epidemic, that this is not the time to cut back CME hours on this important issue and, in fact, the Bureau of Professional Responsibility, that oversees doctors reports, that just last year they received ten reports about doctors in fact overprescribing. So, I'd ask you to follow my light. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Androscoggin, Senator Brakey.

Senator **BRAKEY**: I apologize for rising a second time. I did just want to acknowledge that, yes, I did misspeak. Thank you to Senator Bailey for pointing that out. When I don't write my testimony out ahead of time, sometimes that happens, but yes, we're talking about those who prescribe, not those who dispense. I appreciate the note.

THE PRESIDENT: The pending question before the Senate is Acceptance of the Minority Ought Not to Pass Report. A roll call has been ordered. Is the Senate ready for the question?

Welcome Back Day Ceremony

Welcome back Day Ceremony

THE PRESIDENT: So, at this time we're going to pause the deliberations for the Senate to start the Welcome Back Day Ceremony. Welcome Back Day is a biennial event that's been missing for a little bit with COVID, but we're excited to get it back this year. It's hosted by the Legislature. We invite former members and staff back to the State House. This special day is a moment to see familiar faces, meet our predecessors, and reminisce and share stories of sessions past. As I said, we were unable to host the ceremony two years ago because of the

pandemic, so as President of the Senate for the 131st Legislature it is a true honor to welcome you all back here today to the Maine Senate. We're going to start by inviting Former Presidents of the Senate to the rostrum to make a few remarks. I want to make sure he's here. The Chair is very pleased to welcome to the Senate the Senate President of the 112th through the 115th Legislatures, the Honorable Charlie Pray. President Pray served in the Senate from the 107th to the 115th, was the Majority Leader in the 111th, and the Assistant Minority Leader in the 109th and the 110th. The Chair would request President Pray please step forward to address the Senate. Glad to have you here.

CHARLIE PRAY: We're on a time schedule here, so let's cut this short. I want to express my appreciation for this opportunity to get up here and speak. Some of you don't know who I am, I've been here I think once before to Welcome Back Day, but I've explained the story as to how former presiding officers got up here to give a speech. Governor Cross - most of you don't know who Governor Cross is, Senator Bennett does and a few others always used to come into the State Legislature for Welcome Back Day. Former Governors were the only ones that addressed the Legislature in the House and the Senate and Governor Cross would always come up and wasn't very kind to legislators and what they were doing and always just kind of made them feel a little bit less important than they should be. I was the presiding officer when he came in my first term and he came up, and I sat here for eight years in the Minority, and as was pointed out, I was Majority Leader for a term. My first term as Senate President, Governor Cross comes in. He gets up and he chides the Legislature for everything that it's doing - Republican, Democrat, didn't make a difference. Ken MacLeod, former Senate President, walks in as Governor Cross is leaving the podium and I - the Chair is pleased to welcome the Former Senate President, President Ken MacLeod, to come up and say a few words to the Legislature. Ken comes up and says I wasn't ready to say anything, what am I supposed to say? I said just talk about what it was like when you were presiding officer. I think Ken was the first presiding officer to have multiple terms, he had three terms, followed by Joe Sewall with four terms, followed by myself with four terms, and then you guys went out - or the public went out and enacted term limits, ruining that opportunity to have my record broken. But Ken got up here and, of course, he talked about the importance of the process of getting along, and we've set that since. We haven't had any Governors come back, though, since, so maybe that had some impact on that, too. I just want to quickly point out one thing. Over here on the back wall is former State Senator Howard Trotsky, a Republican. We came in together in '74. We differed on a lot of issues, we agreed on a lot of issues, and we remain friends here some 50 years later. So, the bipartisanship, I know the press gets all the partisan issues, but how many of these bills go through unanimously Ought Not to Pass or unanimously Ought to Pass or there's a compromise, a consensus as a divide, it might be urban rule, it might be north/south, it might be philosophically by party lines, but it - the vast majority of issues are not partisan - the big ones seem to be, and they deserve a little bit more attention. But remember, when you leave here, you guys are all fellow Mainers, you're really neighbors, and you have a lot in common. I want to wish you the best of luck to finishing this legislative session. The sooner you get out of here, the happier I'd be, a lot of people in the State of Maine. Thank you very much.

THE PRESIDENT: So, the Chair is going to just jump script here a little bit because one of our former members must be down in the House, but one of our members actually is here, so the Chair is pleased to welcome the Senate President of the 120th Legislature, Senator Richard Bennett. Senator Bennett served in the Senate from the 118th through the 121st. He served as Assistant Minority Leader in the 119th. He also served in the House during the 115th and the 116th Legislatures, and he returned to the Senate in the 130th and is currently a member of the 131st, and the Chair very much appreciates having the Senator here in this Body with him.

Senator **BENNETT**: Thank you very much, President Jackson. One thing that President Pray didn't tell you is - but he reminded me of this earlier - that Burton Cross, whose building across the way here has his name, actually that was named after Burton Cross because he didn't want the building built, and the Legislature, to get back at him, decided that the best thing to do is to name it after him. So, it stands there as the Burton M. Cross building ever since. It's great to be back, I have to say, it's wonderful to be back, and it's nice to see old friends like Senator Lawrence, I served with years ago, but - and it's great to see people who have served years ago and people who have served recently. You know, we're here as part of a very long story, each one of us, and as I've had the opportunity to come back after a hiatus, I'm reminded of that - how the breadth and depth of Maine's political story - and we're all part of that. And the thing that is most important to me is how - and Senator General Carpenter mentioned this in his prayer, you know, this is the peoples' building, this is the peoples' work that we're doing, and I am so proud of this institution for staying true to that course, that we are the people who are closest to the folks of Maine and it's so critical that we operate in that way, that we have the kind of porous, publicly accessible process that we cultivate here, that we steward here. The fact that anybody can testify on any bill is a rarity in America. The fact that all bills get heard is a rarity in America. This is a special thing that we have here in the Maine Legislature and sometimes we forget it in the hurly-burly. You know, in a - sometime this week, we're going to pass the Solemn Occasion Order to protect the right of the people to petition their government. That's probably coming to us tomorrow on the calendar. And I think that's part of this long tradition we have of fighting for the rights of people, making peoples' voices heard, and I'm just really proud to be part of that and I'm really proud to be back serving after a hiatus and serving with all of you and seeing old friends. Because our role here is to continue to safeguard the blessings of liberty for the people of Maine and it's a tradition that we honor, and I think we remember today and I'm proud to be part of it. Thanks so much.

THE PRESIDENT: We have a couple of the Senate Presidents that aren't - I'm sure they're down in the House Chamber, so we're going to recognize them when they come back in. But we have a number of other people that we're going to recognize. The Chair is pleased to recognize in the Chamber the former Senate Officials who served as Secretary of the Senate and Assistant Secretary of the Senate. Please rise as your name is called and we'll hold the applause until every Secretary and Assistant Secretary has been recognized. We have Joseph G. Carlton, served in the 125th as the Senate Secretary; Valerie Mitchell-Craig, who was Assistant Secretary. I know we still have here Heather Priest, but I don't see her in the Chamber right now,

but certainly she served as the Senate Secretary. Thank you for being here today.

Next, we're going to move into the Senators that are here. In the back, I see the current Secretary of State and former Honorable Senator Shenna Bellows, who served in the 128th, 129th, and the 130th. I also see the Honorable Paula Benoit, who was a Senator in the 123rd and actually owned a retirement home in my district for a while, Senator Benoit. And we saw - we heard him do the prayer this morning, but the Honorable Senator Michael Carpenter who served in the 112th, the 128th, and the 129th. We have the Honorable Justin Chenette who was Senator in the 128th and the 129th. Senator? Over in the corner, the Honorable Ned Claxton, who was a Senator in the 129th and the 130th Legislature. In the back, the Honorable Jonathan Courtney, who was a Senator in the 122nd, 123rd, 124th, 125th. He was the Assistant - actually, the Majority Leader in the 125th and Assistant in the 124th. Jon Courtney. We've already talked about him, but the Honorable Paul Davis, who was a Senator in the 119th, the 120^{th} , the 121^{st} , the 122^{nd} , 127^{th} , the 128^{th} , the 129^{th} , and the 130th. He was the Leader in the 122nd and the 121st and Assistant Leader in the 120th. The Honorable Paul Davis. We have the Honorable Susan Deschambault. She was a Senator in the 127th, the 128th, the 129th, and the 130th, and a pretty fine singer, too. Susan Deschambault. We have the Honorable Robert Foley, who was a Senator of the 129th Legislature. Honorable Senator Robert Foley. Not far away from him, we have the Honorable John W. Hathaway, who was a Senator in the 117th Legislature. John Hathaway. The Honorable Barry Hobbins. He was a Senator in the 114th, 122nd, the 123rd, 124th, and the 125th. He was Democratic Leader in the 125th. Senator Barry Hobbins. In the back, next to John Courtney with the Honorable Dale McCormick. Dale was a Senator in the 115th, the 116th, 117th, and actually did some logging with me in the woods one time. Senator Dale McCormick. On the other side, we have the Honorable Earle L. McCormick. Earle was a Senator in the 123rd, 124th, 125th, and the 127th. The Honorable Earle McCormick. Right alongside of Earle, we have the Honorable John 'the Legend' Patrick. He was a Senator in the 125th, the 126th, and the 127th. Senator John Patrick. Right in that same area with the Honorable Gary Plummer. Gary was a Senator in the 126th. Senator Gary Plummer. In the back, we have the Honorable Sharon A. Treat. Sharon was a Senator in the 118th, the 119th, the 120th, the 121st. She was Assistant Democratic Leader in the 120th and Democratic Leader in the 121st. Senator Sharon Treat. We have the Honorable Howard M. Trotsky, who was a Senator in the 107th, the 108th, the 109th, and the 110th. Senator Howard Trotsky. Up here, we have the Honorable Bruce Bryant, who served in the 121st, the 122nd, the 123rd, and the 124th. Senator Bruce Bryant. In the back, we have the Honorable Mary Small. She was in the Senate, the 117th, the 118th, the 119th, and the 120th. She was the Republican Leader in the 120th. Senator Mary Small. And never late, always on time the Honorable Severin M. Beliveau. Severin was a Senator in the 103rd and the 104th. Senator Severin Beliveau.

As far as other Honorable staff that was here, we have the Honorable Bob Asselin, who was a Sergeant-At-Arms and actually served in the New Hampshire House. Bob Asselin. So, there's a number of staff that I'm not sure if they're all in here or not, but I'm going to read them all off and then we'll have them recognized. The Honorable Dorothy Canelli, who was Senate staff; the Honorable Marilyn Canavan, who was on Senate staff and served in the House; Andrew Roth-Wells, David Loughran,

Diane Johanson, Edna Cayford, Emily Cook, Meghan Russo, Sara Vanderwood, Megan Gean-Gendron, and Kim Russell, all worked here in the Senate. Would they all please rise and accept the greetings of the Maine Senate?

We also have here the Honorable Bonnie Titcomb Lewis. She was - Senator Bonnie Titcomb Lewis, there she is.

So, I believe that's every former member of the Body who returned today. If I missed anyone, could you please rise to be recognized? Wow, awesome. That's always - that's right.

And although I think he's going to rise later on to speak, we have - I'm going to recognize the Honorable Mark Lawrence, who obviously served with us here in the Chamber. He was Senate President of the 118th and the 119th Legislatures. Senator Mark Lawrence served in the Senate from the 116th to the 119th, was Minority Leader in the 117th. He served in the House on the 114th, 115th, and 128th, and returned to the Senate for the 129th, 130th, and is currently a Member of the 131st. The Chair would very much like Senator Lawrence to rise and be recognized by the Maine Senate.

So, it is great to have so many familiar faces back in the Chamber. And I may say this often, but I truly mean it - in the Legislature, we are a family, which includes sitting lawmakers, former lawmakers, and next-generation lawmakers to come. It is undoubtedly a little bit dysfunctional at times, but most of us are here today for similar reasons, as many of the former presiding officers that spoke about. We do love our state and we want to make things better for the people that we love - our friends, family, and neighbors, and the Legislature can be a place of frustration and chaos, but it can be a place that gives way to surprising friendships and great bipartisan triumphs. In Welcome Back Day, a tradition that started nearly 70 years ago in the House, is a good reminder of that. Looking around the room, I see many people who have taught me the way things work here in Augusta, both good and bad, and taught me the way government should and can work for the people we are so fortunate to serve. I see a lot of people here who challenged my long-held beliefs, which have been instrumental in the way I view the world now. In some cases, these challenges led me to expand my views, and in others, these challenges strengthened my beliefs and my values. And it's a real honor to host former the former Honorable who I haven't seen yet, Libby Mitchell, here today who led the nation as the first woman to serve as both Speaker of the House and President of the Maine Senate. When Libby comes in, I'm definitely going to bring her up. Obviously, we've had the Honorable Charlie Pray, who holds the record for the longest serving Senate President. And the folks who make every day Welcome Back Day in the Senate, the Honorable Mark Lawrence and the Honorable Rick Bennett. As Senate President, I honestly feel very fortunate to serve alongside these two former Senate Presidents that have been, you know, certainly a guiding force for me when things I didn't quite know or weren't sure how to proceed with. And finally, I would be remiss if I didn't pay tribute to those who are no longer with us. I will always be grateful for the Honorable Joy O'Brien's commitment and dedication to this institution, the state and the people of Maine. She served as Secretary of the Senate for 25 years and you all know she ran this Chamber with an iron fist - but in a good way.

On Welcome Back Day, I am reminded how fortunate I am to serve in the Legislature, to serve as Senate President, and to serve with all of you. You'll always be welcome back in the Chamber with open arms and I definitely want to tell you that it has been a great, great privilege to either serve with you or

welcome you back here today as someone that served in this Chamber before me. It is a true honor to stand anywhere in this Body, but certainly up here, and I hope that for all of you, you have great blessings and today is another great day for all of you that have been here in this Chamber. So, thank you very much.

So, just to be clear, we actually are way ahead of schedule. But I still obviously have Senate President Mitchell that I want to recognize when she comes in. We are going to have lunch downstairs at noon, but a little bit off script, if any Members, former Members, have any remarks, now would be the perfect time, which is fine. If you don't, that's okay, too, but certainly want to open it up for any Member that might've had something they wanted to say.

THE PRESIDENT: Senator Davis, would you like to come up, sir? Senator Davis, you want to -

Senator DAVIS: (INAUDIBLE)

THE PRESIDENT: Senator Davis, I think I'm going to try really, really hard to pay for that out of my own personal account.

Senator DAVIS: (INAUDIBLE).

THE PRESIDENT: So, the Chair is going to bring you back into your printed calendar until we see Senator Mitchell, Senate President Mitchell, rejoin us. We might have perfect timing. Right on time, perfect timing. So, the Chair would like to recognize in the rear of the Chamber, the Honorable John L. Martin, who served in the Senate in the 121st, the 122nd, the 123rd, the 124th, and was Assistant Leader in the 124th. Senator John L. Martin. Senator Martin, Speaker Martin, you just missed - I opened it up for any former member that would like to make any remarks up here. You sure? Okay. Well, if not, then the Chair is also very pleased to welcome in the Senate the President of the 124th Legislature, the Honorable Libby Mitchell. President Mitchell served in the Senate during the 122nd, 123rd, and as Majority Leader - as a Majority Leader in the 123rd. President Mitchell served in the House from the 107th through the 11th, and the 115th to the 118th. During her time in the House, she served as Assistant Majority Leader in the 109th and the 117th, and Majority Leader in the 110th and the 111th, and as Speaker of the House in the 118th. The Chair would also note that President Mitchell is the first woman in Maine to serve as Speaker and the first woman in the country to serve as both the Speaker and the President. The Chair would request that President Mitchell please step forward to address the Senate.

LIBBY MITCHELL: Wow. Never give a former elected official a microphone because we can't say no. But I want to say that I have just had the privilege of being in the House with John, and I think we're the oldest people on the face of the Earth who are in the Legislature. We stood up for every legislative session since Maine became a state, I think, between the two of us. I'll be very brief, you have many more important things to do. But I just want you to know, those of us are on the outside now, looking in, how much admiration we have for you and the work that you're doing. It is a job of grave responsibility, but your integrity is unparalleled. The respect we all have for this Body is just amazing. I had the privilege of serving with the Chair of Judiciary - not serving with, but on a commission that she chaired so well, and knowing many of you personally and from the House days, it's just a real

pleasure to be here. And I'm a big fan of this one over here, I have to tell this story one more time. When I was presiding in this Body, this man was so - as you know, he's passionate about the logging industry. He's passionate about the workers. And so, he made this powerful speech and at the back of the room there was a lobbyist who kept looking at his watch because he knew where the votes were and this gentleman, after this powerful speech, basically stood up and said 'I give up, I'll be back another day.' Well, I was so impressed with his speech, I'm the only person in this Chamber who voted for the bill, but - but at any rate, he does come back and fight for another day, as you all do. And, again, and this one over here is - I've known him forever and every time I see him now, I want to say play ball, because he serves here but he also serves the kids of Augusta with baseball. So, you're amazing. Some of you I served with, and Senator Bennett is back again, I see. And so, as you all know, when you leave this Chamber, you're friends, you're family, and that's what's so special about being in this Body. You never stop caring about the friends you've made here. Thank you for the honor of a few words, and keep up the excellent work, we're so proud of you. Thank you.

THE PRESIDENT: The Chair would also like to recognize former members of the Body: Senator David Woodsome, Senator Scott Cyrway, and Senator Jim Dill, who all served in here up until the last session and now are down in the House. Good Senators.
