The following Joint Resolution: (S.P. 712)

JOINT RESOLUTION DESIGNATING MAY 1-7, 2023 AS TARDIVE DYSKINESIA AWARENESS WEEK

WHEREAS, many people with serious, chronic mental health conditions, such as schizophrenia, bipolar disorder or severe depression, or gastrointestinal disorders, including gastroparesis, nausea and vomiting, require treatment with medications that work as dopamine receptor blocking agents, or DRBAs, including antipsychotic medications; and

WHEREAS, while ongoing treatment with these medications can be very helpful, and even lifesaving, for many people, it can also lead to tardive dyskinesia; and

WHEREAS, tardive dyskinesia is a movement disorder that is characterized by random, involuntary and uncontrolled movements of different muscles in the face, trunk and extremities; and

WHEREAS, tardive dyskinesia can develop months, years or decades after a person starts taking DRBAs and even after they have discontinued use of those medications. Not everyone who takes a DRBA develops tardive dyskinesia, but if it develops it is often permanent; and

WHEREAS, it is estimated that over 600,000 Americans suffer from tardive dyskinesia, and, according to the National Alliance on Mental Illness, one in every 4 patients receiving long-term treatment with an antipsychotic medication will experience tardive dyskinesia; and

WHEREAS, tardive dyskinesia is often unrecognized and patients suffering from the disorder are commonly misdiagnosed, and regular screening for tardive dyskinesia in patients taking DRBAs is therefore recommended by the American Psychiatric Association; and

WHEREAS, while years of difficult and challenging research have resulted in recent scientific breakthroughs regarding tardive dyskinesia, it is important to continue to raise awareness of tardive dyskinesia in the public and the medical community; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Thirty-first Legislature now assembled in the First Special Session, on behalf of the people we represent, take this opportunity to designate May 1-7, 2023 as Tardive Dyskinesia Awareness Week and respectfully encourage each individual in the State to become aware of and better informed about tardive dyskinesia.

Representative **KUHN**: Thank you, Madam Speaker, Esteemed Members of the House. I am pleased to rise today to offer a sentiment in memory of Mary T. Honan. Mrs. Honan lived to the age of 97, one of Falmouth's oldest residents, when she passed earlier this year, actually two months ago today. For 84 of her years, she lived just down the road in my neighborhood and she was a formidable leader in our community. The sentiment that was read reflected many of Mrs. Honan's professional accomplishments but I wanted to take a moment to share a couple of more personal remembrances shared by her family because Mrs. Honan also knew how to have fun.

St. Patrick's Day was a particular favorite. Following in her Irish parents' tradition, she hosted an all-day open house every year where the tea kettle would whistle all day and Irish bread and Irish tunes were available in abundance. Birthday celebrations were also important. Her 95th birthday took place during COVID, unfortunately, but the town of Falmouth showed up in great numbers to celebrate her. This included a parade by her home led by five fire engines with lights flashing, followed by about 50 vehicles filled with family and friends, and finishing with a police cruiser, also with lights flashing, all cheering to Mary T. as she sat at the end of her driveway, waving to her fan club.

Mrs. Honan was dedicated to her family, her community, and her church. She was predeceased by her husband, Jimmy, of 64 years and is survived by five children, 10 grandchildren, dozens of nieces and nephews and other loving family members. Many of those folks are here with us today in the gallery to commemorate Mary T. Honan's life here in the House of Representatives. Mrs. Honan will be warmly remembered and sadly missed. Representative **RUDNICKI**: Thank you, Madam Speaker. I rise in opposition to the pending motion. I have a very good friend of mine who is an owner of a home health care business.

And when you apply to a business, any business, it takes time for that business regardless. It takes time out of their day. And for somebody to be able to apply, take up their time and then still go and collect unemployment benefits on another business, it's just wrong. We have a tendency to just give and give and give money in this Body to anybody who comes before us and asks and, to me, unemployment benefits are paid for by the businesses. And if somebody comes in and applies to my friend's business, who is a home health care owner; that's something that we're in very desperate need of; and then to use their name on their unemployment forms that oh, I applied there but then when they're called back to do an interview or anything like that and then they just ghost them; and for those of you that don't know what that means, just ignore them; it's wrong.

And we have a vehicle here that could actually force people to actually keep the interview or at least call and cancel and not still get their benefits if they don't want to bother to do that. My friend had actually been calling the Department of Labor, sending a report to the Department of Labor whenever somebody didn't show up when they made an appointment or especially because they're using her name on their unemployment forms and she actually got an email and she forwarded me a copy of it, she actually got an email from the Department of Labor to tell her to stop doing that. Well, honestly, she's not going to stop doing it, she's going to continue to do it, but we have to take that in consideration. So, Madam Speaker, I request a roll call and follow my light.

The SPEAKER: The Chair recognizes the Representative from Vassalboro, Representative Bradstreet.

Representative **BRADSTREET**: Thank you, Madam Speaker. I appreciate your indulgence this morning. Evidently, we have some glitches in our technology here, so, I appreciate that and I appreciate the other side of the aisle cooperating as well. I rise in opposition to the pending motion. I understand that the Bureau of Labor thinks they have this under control. However, we keep getting a lot of complaints from employers where they're holding interviews or expecting to hold interviews with people who are drawing unemployment benefits and they just don't show up. There seems to be too many of them to have it just happenstance. We think there's something within the system that needs to be fixed and we think the Department should be more rigorous in their efforts getting people back to work. Thank you, Madam Speaker.

The SPEAKER: The Chair recognizes the Representative from Rumford, Representative Henderson.

Representative **HENDERSON**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House, I rise today in opposition to the motion of Ought Not to Pass for LD 245, "An Act to Require a Person Receiving Unemployment Benefits to Attend Scheduled Interviews to Fulfill the Work Search Requirement." This bill amends the employment security law to provide that an individual who refuses to appear for an employment interview scheduled with an employer for a suitable job opportunity is disqualified from receiving unemployment benefits. The bill also requires the Department of Labor, Bureau of Unemployment Compensation to establish an online portal for employees to report individuals who refuse to appear for scheduled employment interviews.

In my 22-plus year working career, I have been both an employee and an employer, at times holding two jobs, even at times, and I would say in my early 20s; oh, to be in my 20s again; working from 4:30 in the morning till 11:00 at night, getting up in the morning and starting the process all over again. I can promise you I could not sustain that working lifestyle where I stand today. I am currently employed as a support manager with a telecommunications company and help oversee our locations across Maine, New Hampshire and Vermont. Part of my role in the company is recruiting, onboarding and training new employees. In the past two years, we have seen a significant uptick in no-shows or ghosting interviews. Any decent employer or someone who is trying to build a team, we put a lot of care into carefully crafting interviews based on an applicant's specific qualifications and working career. At times, it can take a manager or a hiring manager in our company anywhere from 45 minutes to an hour and a half to carefully craft an interview. We have to ensure that we have proper staffing in our stores so on the sales floor when we're pulled away for an interview that could potentially last an hour or more depending on the organic flow of that interview, that our staff out front have proper support, oftentimes having to bring in either team leads or assistant managers. We do share employees across our locations.

So, an interview; for certain locations, mine specifically, and we are a retail location, it isn't just a simple thing that we do; it is time-consuming and it is costly and over the course of the last two to three years, that uptick, it has now become common knowledge that we have to schedule anywhere from six to eight interviews just to get one person to show up. We have changed our approach from just sending emails in responding to Indeed applicants, we've changed our approach to emailing, making a phone call, and if they have specified they have a cell phone, we also follow up with a text message. We keep track of every person that responds to us. We give them an opportunity to choose the date and time and we schedule around them, and they are still not showing up. This is a huge cost on our company, not to mention the mom-and-pop stores, the smaller retail locations within our State, and I would urge if we have a desire to see the people in Maine get back to work, we need to pass laws like this that would require them just to do the bare minimum, to show up at an interview and to show that they truly are interested in being employed before they could receive those benefits. Thank you.

The SPEAKER: The Chair recognizes the Representative from Fort Kent, Representative Theriault.

Representative **THERIAULT**: Thank you, Madam Speaker, Ladies and Gentlemen of the House. This should be a bipartisan bill that we should all support. Just last week, we had the pleasure of having you up in the County and small businesses are really struggling under the weight of the labor shortage. And I will say, in my neck of the woods, unemployment insurance is an important part of our economy, especially for those that have seasonal work. Right now, the folks that typically work in the woods are out of work and they're relying on unemployment and so we should hold to a certain high level, you know, some basic needs and basic asks for those that are using the unemployment system because there are those that do need the system and that are really helped by it, getting perhaps a couple months for them to get on their feet. But I can't go through any sort of employer, from restaurants to auto parts store, you name it, in my district that doesn't come up to me and say that this is a major issue and for the Department to say that they've got it under control is really a stretch. And so, I actually had a business owner who didn't support me in the

last election come up to me and they just couldn't wrap their head around why this wasn't going to get bipartisan support because it's something that the employer felt like if they were going to take four or five hours out of their schedule to be scheduling folks for interviews and 90% of them were missing, that there should be some sort of follow-up. And with the worker shortage, the future of small businesses are on the line here and we can't afford to make any more mistakes. We have to hold people accountable and we also have to protect the unemployment system for those that truly need it. Thank you.

The SPEAKER: The Chair recognizes the Representative from Bangor, Representative Roeder.

Representative **ROEDER**: Thank you, Madam Speaker. Madam Speaker, I, myself, have been in the same situation that my colleagues from across the aisle have described in interviewing people that just don't show up. I wanted to mention a couple of facts that the Department of Labor brought to us because I hope it will ease everybody's mind about our unemployment system not being exploited. The Department of Labor and the Bureau of Unemployment has a system in place whereby employers can report people; whether they don't show up, just so that their business and their name is not being used as that tick box for; I did go on an interview today for folks on the unemployment. We heard that 314 people were reported on this tipline. Fifty-two of those 314 people were actually on unemployment and collecting. Two of those 52 had to do with missing interviews. So, it seems like we are trying to legislate good behavior from people rather than hold people on unemployment accountable. We have no way of knowing if an interviewee coming in to see us or who makes an appointment to come in for an interview is collecting unemployment. Many people are not. In fact, the majority, if we are to believe the Department of Labor's statistics. So, I am very sympathetic, especially to the folks that have to do what I did and try to hire people based on a bunch of people that just don't show up, but it doesn't seem to be a problem at this point. Thank you.

The SPEAKER: The Chair recognizes the Representative from Fairfield, Representative Rudnicki, and inquires to why she's rising.

Representative **RUDNICKI**: If I may rise one more time to speak, Madam Speaker, I'd like to read the email that the Department of Labor actually sent to a business.

The SPEAKER: The Member may proceed.

Representative **RUDNICKI**: A few key points to remember on a form that they expect people to fill out. A prospective employee must decline an actual offer of employment. Failing to show up in person or by phone for an interview is not a job refusal. Also, texting, leaving messages for prospective employees, even with a detailed offer, doesn't count. You must receive a response from the person. It can't be one-way communication. There's an exception for letters mailed via return receipt requested but I doubt you're going to those lengths in most situations. A bona fide offer of employment would include job title, rate of pay, location, schedule, job responsibilities, etcetera. The job must be sustainable for the prospective employee's experience, training, pay, distance from home, etcetera. Please use the attached form rather than sending the applicant's resume.

So, basically, they're saying don't bother us. Thank you, Madam Speaker.

Representative **ZEIGLER**: This bill would like to remove a 100-megawatt limit on clean energy sources. If that were to happen, then it would dampen renewable energy projects and their needed capital in our State while sending financial support to larger projects in other states and Canada. Thank you.

Representative **ARDELL**: Thank you, Madam Speaker. I'd like to speak to the motion. My name is Donald Ardell, representing District 6, and I rise today in opposition of the Ought Not to Pass motion for LD 622, "An Act to Create Equal Opportunity Access to Clean Energy by Removing the 100-megawatt Limit on Clean Energy Sources."

Maine's energy policy, Title 35-A, adopted in 1999 reads, quote, Policy: In order to ensure an adequate and reliable supply of energy for Maine residents and to encourage the use of renewable, efficient and indigenous resources, it is the policy of this State to encourage the generation of electricity from renewable and efficient sources and to diversify electricity production on which residents of this State rely in a manner consistent with this section.

The Statute continues to state Maine's energy goal to be 80% renewable energy by 2030 and 100% by 2050 and goes on to define renewable capacity resource as a source of electrical generation that relies on a list of six sources whose power production capacity does not exceed 100 megawatts; fuel cells, tidal power, geothermal installations, hydroelectric generators and biomass generators. Subsection 3210, amended in 2019,

however, designates wind and solar installations as not subject to the 100-megawatt limit to be considered as renewable capacity resources.

The intent of past legislators was clearly to limit hydropower and other competing sources of energy generation and to prioritize solar and wind, apparently to diversify Mainer's energy sources. However, is diversity in sources of electrical generation for the sake of diversity best for Maine and Mainer's? Predictably, solar power installations that are only fueled by solar energy during the day are unable to produce electricity at night. Were Maine a location for high demand for home and business cooling during the day as southern states are, I would agree that solar electricity generation is a wise energy choice. But Maine is far more reliant on winter heating than summer cooling. On winter nights, when Mainer's home heating needs are the highest, solar is taking the night off. Wind power generation is similarly inconsistent and yet Mainer's electricity demand continues regardless of whether the sun is shining or if the wind is blowing. By way of example, on the coldest winter night of 2022 in Aroostook County, the overnight low air temperature was negative 35 degrees Fahrenheit and the wind speed was zero. Neither the sun was shining nor the wind blowing and yet Mainer's winter home heating energy needs were the highest. Ironically, when wind and solar are not producing, backup generators powered by natural gas or diesel are used to make up the deficit, which means Maine's energy backup system is the very source of energy we vowed to leave behind. If wind and solar are continued to be prioritized, unless a policy change is made, Maine will be able to reach neither its 2030 goal of 80% nor its 2050 goal of 100% of renewable energy and natural gas and diesel generation backup will continue to be relied on. By disincentivizing the six other renewable capacity resources, we are in fact incentivizing the use of natural gas and diesel generators. Hydropower, however, could have been running that cold winter night, capturing kinetic energy through water flow day and night every night. Hydropower is a source of energy that is inexpensive, clean and available and, best of all, hydropower needs no natural gas or diesel backup.

To return to Maine's stated energy policy, economy to the consumer is not mentioned and apparently not considered. Maine's seniors, veterans and disabled living on fixed incomes, pensions and Social Security are reliant on our sound decision-making as a legislative Body. In closing, I'd like to suggest Maine's energy policy, one that emphasizes an adequate and reliable supply for Maine's residents and that encourages the use of renewable, efficient and indigenous resources while prioritizing wind and solar, is in fact creating the structure in which the least reliable sources of power are creating an increased need for backup natural gas and diesel power generation. Our policy is failing but hydropower can attain our goals. Thank you for your careful consideration of the bill. I respectfully ask this Body to vote with me and Mainer's truly interested in clean energy a vote of no on the Ought Not to Pass motion today. Thank you.

The SPEAKER: The Chair recognizes the Representative from Winter Harbor, Representative Faulkingham.

Representative **FAULKINGHAM**: Thank you, Madam Speaker. I'll try to keep my remarks short. I appreciate the remarks from my good colleague from Monticello and I would also like to thank the Representative from Montville for his answer to why there's opposition to this bill because the reason I rise is because this is a truly perplexing question for me. I have had great difficulty understanding why there is opposition to this bill and this is one of those things where we should all agree. Regardless of your opinions on climate change, how it's caused,

any of that, there are issues where it seems like we could agree and hydro is one of those issues. Hydro is clean, renewable, carbon-free, cheap energy. It can be supported by everyone, no matter what your opinions are on climate change and its causes. If we have determined that hydropower is renewable up to 100 megawatts, why all of a sudden at 101 megawatts is it not clean energy anymore? This makes absolutely no sense and today, I hear for the first time a reason for why there's opposition to this; because it comes from Canada. So, if all the energy in Maine was diesel-powered, fossil fuel-powered and Canada had all kinds of clean energy, we wouldn't take the clean energy from Canada because it's from Canada? That makes no sense, Madam Speaker. Canada has an abundance of hydro energy. That is true. Why we would want to keep it out of Maine defies logic. This is such a simple remedy and it wouldn't cure all of our energy problems but there's no reason to keep this cap in place. I urge the Members to vote Ought Not to Pass on this motion.

The SPEAKER: The Chair recognizes the Representative from Carmel, Representative Thorne.

Representative **THORNE**: Thank you, Madam Speaker. I rise in opposition to the pending motion on the floor and would just remind Madam Speaker and the Members of this House that most of our windmill energy comes from Canada. Thank you.

The SPEAKER: The Chair recognizes the Representative from Paris, Representative Andrews.

Representative **ANDREWS**: Thank you, Madam Speaker. I'd just like to point out one of the reasons this bill is being opposed is because it creates an artificial monopoly for wind and solar in this State. Thank you.

The SPEAKER: The Chair recognizes the Representative from Houlton, Representative Swallow.

Representative **SWALLOW**: Thank you, Madam Speaker. I also oppose this motion. I come from Houlton, which has its own separate electric company; Houlton Water Company and Electric. We have the cheapest power in the State of Maine. It now all comes from Canada, primarily hydroelectric. It's been a great asset to our community and the surrounding communities it serves. We are no longer on the grid, we no longer have to pay those fees over the grid and our electric bills are generally half to a third of what the rest of the State is paying. Thank you.

The same Representative **REQUESTED** a roll call on the motion to **ACCEPT** the Majority **Ought Not to Pass** Report.

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The **SPEAKER**: The Chair recognizes the Representative from Wiscasset, Representative Polewarczyk.

Representative **POLEWARCZYK**: Madam Speaker, I rise in opposition to the motion.

I'm finding this whole thing to be an incredible adventure. The adventure actually started during my campaign when I began knocking on doors and one of the first doors I knocked on, Madam Speaker, was a gentleman that was very pleasant to talk with, very much in favor of ranked-choice voting. I talked with him for a while, went on to the next door and, although I had never asked any person whose door I knocked on where they thought, they brought up the subject. And had I known at that time that I'd eventually be in this Chamber, I would've kept track of the numbers. I would love to be able to be here today and say it was 2:1, 5:1 or 50:1. I can't do that because I didn't know I'd be here. But what I could say is that of all the people I talked with, there was only one voter who was in favor of ranked-choice voting. Back in the 1800s, Maine actually determined the results of its elections based on a majority vote. In those days, if there was no majority, you held another election and a third election and a fourth election. The end result was that people lost a great deal of confidence in our election process. In 1848, the Seventh Amendment to the Constitution of Maine replaced the words 'majority' with the words the 'greatest number.' And from that point on, for 168 years, plurality became the means of us determining the results of our elections.

In 2016, we had the citizens' initiative. It was a referendum that was passed on November 8, 2016, and the voters decided 52% to 48% in favor of ranked-choice voting. The Maine Supreme Court was asked to provide an opinion on the constitutionality of the referendum and on May 23, 2017, responded that ranked-choice voting conflicts with the Maine Constitution for Governor, State Representative and State

Senator. As a result of that decision, ranked-choice voting became applicable for primary elections, the Presidential election and for Federal Representatives and Senators. So, here we are today with a mix; plurality deciding elections in some cases and ranked-choice voting deciding in other elections. The objective of this bill was to specify that all elections are to be decided by plurality. Not only the Governor, Representatives and State Senators as required by the Constitution but also primary elections, elections for the President and elections for the Federal Representatives and Senators.

As I went through the campaign, I found an increasing number of my constituents complain about ranked-choice voting. They view it as a complicated system, they're not sure where it applies and where it does not apply, many are not sure how to complete the form, many don't want other candidates but feel an obligation to fill it in for fear that their vote will be disregarded, and many believe it violates one person, one vote. It is especially divisive in the case where the person with the most votes loses as a result of applying second choices and becomes an increasing question of the validity of the election. Plurality had been accepted and has worked for 168 years. It appears like we're trying to repeat history once again. Our history has shown that majority voting has led to a lack of confidence in our elections. That lack of confidence resulted in the change to plurality voting by the Seventh Amendment. Are we repeating history here? Having a voting system where plurality is used in some elections and ranked-choice voting in others decreases the confidence our constituents have in our elections. I urge my colleagues to vote in opposition to the motion. Thank you.
